

Queens Creek Elementary School Parent and Family Engagement Policy Title 1 Schoolwide School Revised January 2025

In support of strengthening student academic achievement, Queens Creek Elementary receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). - 3. families are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and
- 4. other activities are carried out, such as those described in Section 1116 of the ESSA.

## Written Policy

## ANNUAL TITLE I MEETING

Queens Creek Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all families of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the families' requirements, the school's parent and family engagement policy, the schoolwide plan, and the school-parent compact.

Queens Creek Elementary School will hold an annual fall meeting in conjunction with Open House to:

- Inform parents and families about the school's facilities and its Title I Schoolwide designation.
- Provide parents and families with an overview of the Title 1 program.
- Provide parents and families with information concerning parent and family engagement requirements, assessment data, school performance profiles, and methods of measuring students' progress.
- Inform parents and families of summary results of the prior year's EOG Testing, if available.

Queens Creek Elementary will provide to families:

- Flexible number of meetings, such as meeting in the morning or evening, and may provide with Title 1 funds, transportation, childcare or home visits, as such services related to parent and family engagement.

- Queens Creek's Parent and Family Engagement policy will be distributed annually to families of all students. A link to the document will also be provided on our school's website.
- Newsletters, social media, parent communication apps (such as Class Dojo), and the all-call system to inform families of upcoming events, meetings, and programs.

Queens Creek Elementary will assist in successful transitions by coordinating with the following staff and programs:

- English Language Learners, English Language tutors and district leaders
- Public preschool and middle school
- Daycares
- School nurse, counselor, military liaison, and social worker
- Parent Teacher Organization (PTO)

#### **COORDINATION OF SERVICES**

Queens Creek Elementary will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support families in more fully participating in the education of their children by:

- Notifying parents and families of additional assistance from outside agencies such as: local food banks, United Way, PRIDE, church programs for assistance, recreation/sports opportunities, Onslow County/Swansboro Public Library, Christmas Cheer, Salvation Army, Swansboro Rotary Christmas help, Angel Tree and Toys for Tots.
- Inviting participation by adults from the community into school assemblies and programs.
- Enabling distribution of food donated by local churches, businesses, and other programs.
- Promoting recreation/sports/arts opportunities, Boy Scouts, Girl Scouts, the public library and summer programs.
- Accessing services as needed through Onslow County Partnership for Children, Boys and Girls Club of Onslow County, and YMCA.
- Hosting Teacher Interns from UNCW, ECU and other universities in our classrooms to help prepare them as highly qualified teachers.

### **BUILDING CAPACITY OF SCHOOL STAFF**

Queens Creek Elementary will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of families, in the value and utility of contributions of families, and in how to reach out to, communicate with, and work with families as equal partners, implement and coordinate parent programs, and build ties between families and the school by:

- Sending monthly newsletters and posting information on teacher/school websites and/or Class Dojo.
- Holding parent conferences to assist in helping parents understand the state curriculum and monitor their child's progress.
- Hosting schoolwide nights to provide parents with strategies to improve student achievement, information on curriculum, standards, assessments, and proficiency levels.

Queens Creek Elementary will provide other reasonable support for parent and family engagement activities as families may request by:

- Offering parent and family engagement activities at flexible times.
- Encouraging parents and families to attend other school events and conferences, volunteer in classrooms and observe in the Title I Program.
