# **SUMMARY OF POSITION:**

Under direction of management and teaching personnel, assist in the development and ongoing functions of the school's extended learning program. The extended learning program will be open for students from all grade levels (K-12) who will be recommended, by administration, counselors, parent(s), guardian(s), or their teachers, to access additional learning outside the regularly scheduled learning day. One-on-one tutoring, group instruction, team building, and challenge course activities will be planned by a teacher with the ongoing assistance of the ELP Tutor. Perform related work as required. This position will work directly with students in a class setting, small group, or individually in an academic setting

## MINIMUM QUALIFICATIONS - EDUCATION AND/OR TRAINING:

Possess a high school diploma or equivalent. Able to demonstrate proficiency in basic reading, writing and math skills at a level required of high school seniors. One year of experience in working directly with students to support their learning, or a combination of education and experience.
