| <p>District Legislative Committee</p> <ul style="list-style-type: none"> Meeting Dates: First Thursday of the month (except July) from 12PM to 1:30PM Purpose: These representatives are responsible for monitoring legislation of interest to or affecting school districts and reporting back to the Board of Education.
