



## FREQUENTLY ASKED QUESTIONS

### What's included in Visitation tuition?

Visitation's tuition includes more than the excellent education our students expect from Vis. Also included is Visitation's lunch program, yearbook, all books and technology including one-to-one devices for students in K-12.

### Does a financial grant cover costs outside of tuition and fees?

At Visitation, it is vital that each student can fully participate in all our programming. If any outside costs become a hindrance to participation, please contact the Financial Grants Office for assistance with these costs.

### Do families have to reapply for a financial grant each year?

Since a family's financial circumstances can change from year to year, we ask that all families requesting assistance apply and provide supporting documentation each year. If your family's financial situation remains relatively the same, Visitation is committed to providing your family with a similar financial grant.

### How are financial grants determined?

Visitation is committed to providing an excellent, affordable education. All awards are based on demonstrated need and the Financial Grants Committee reviews each applicant individually using data from the SSS application (School and Student Services) to ensure that the awarding of financial grants is determined in an equitable manner.

All awards are based on demonstrated need, and the Financial Grants Committee reviews each case individually.

In addition to Visitation financial grants, funding may also be available through the Catholic Services Appeal Foundation (K-12) or the Aim Higher Foundation (K-8).



Visitation financial grants typically follow a student through to graduation.

### PARENTS OF STUDENTS ENTERING KINDERGARTEN-GRADE 12

Complete the Parents Financial Statement through the SSS financial grant application and submit, with fee, by January 13, 2025.

### ALL FAMILIES WHO ARE APPLYING FOR A GRANT AT VISITATION FOR THE FIRST TIME

Upload a copy of your 2024 and 2023 W2 forms to the SSS application by January 13, 2025.

Upload a complete copy of your 2023 and 2022 Federal Income Tax Returns (Form 1040 and related schedules, including partnership and Subchapter S returns) to the SSS Application by January 13, 2025. The Financial Grants Committee cannot consider a grant for your child without these forms.

### FAMILIES WHO RECEIVED A FINANCIAL GRANT AT VISITATION FOR THE 2024-25 SCHOOL YEAR

Upload a copy of your 2024 W2 Forms to the SSS application by January 13, 2025

Upload a complete copy of your 2023 Federal Income Tax Returns (Form 1040 and related schedules including partnership and Subchapter S returns) to the SSS Application by January 13, 2025. The Financial Grant Committee cannot consider a grant for your child without these forms.

*Additional funding may also be available through the Catholic Services Appeal Foundation (K-12) or the Aim Higher Foundation (K-8). To apply for a grant from these organizations, complete the TADS financial grant application, with fee, by February 1, 2025.*

*In some circumstances, Visitation may require additional supporting documentation to complete the financial grant process.*
