6.C. Approve Resolution – Tax Roll Correction

The Board accept the recommendation of the Superintendent and approve the following resolution:

WHEREAS, James Lilla ("Owner") owns taxable real property in the Town of Newburgh identified on the Town of Newburgh tax map as: SBL # 125-1-19; and

WHEREAS, the Owner submitted an Application for Correction of Property Tax Assessment for 2024 ("Tax Roll Correction Application") pursuant to RPTL §739 on or about July 17, 2024; and

WHEREAS, the Supreme Court of the State of New York County of Orange approved the Stipulation of Settlement on or about December 24, 2024 and has recommended the correction of the tax roll and the issuance of a new tax bill for the reasons set forth in a letter bearing that date and the attached documentation;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Wallkill Central School District ("District"), pursuant to its authority set forth in RPTL §739, hereby authorizes and confirms the following actions:

1. Determines that a clerical error by the Town Assessor exists for the reasons set forth in the letter dated July 17, 2024 from the Orange County Director of Real Property Tax Service;
2. Approves the Tax Roll Correction Application;
3. Orders a correction of the 2024-25 Tax Roll of the Wallkill Central School District so that the tax levied on real property identified on the Town of Newburgh tax map as SBL # 125-1-19 be reduced from \$145,800.00 to \$112,450.00; and
4. Directs the District's School Tax Collector to issue a corrected tax bill in the sum of \$2,759.28 to the Owner, together with a notice indicating that the Tax Roll Correction Application has been approved.

6.D. Approve Memorandum of Agreement – Wallkill Teachers' Association

WHEREAS, the Wallkill Central School District ("Wallkill") Board is desirous of entering into agreement with the State University of New York at Potsdam for student teaching and related clinical experiences for the mutual benefit of the District and students matriculating in various educational programs in the SUNY system, now therefore be it:

RESOLVED, that the Board of Education of the Wallkill Central School District authorizes the District to enter into the following agreement with SUNY Potsdam of the SUNY system and authorizes the Superintendent and/or the Board President to execute the agreement on the Board's behalf effective for the 2024-2025 school year and shall remain in place for five (5) years.
