AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to incentive payment that we communicated to District management and the Board of Directors in a letter dated October 17, 2024. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Renton School District No. 403 from September 1, 2022 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll bonus and incentive payments
- Associated Student Body activities at Hazen High School
- Self-insurance unemployment, workers compensation
- Procurement public works projects
- Compliance with public works projects change orders

- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Accounts payable general disbursements
- Financial condition reviewing for indications of financial distress
- Open public meetings compliance with minutes, meetings and executive session requirements

INFORMATION ABOUT THE DISTRICT

Renton School District No. 403 serves approximately 14,300 students from preschool through the 12th grade in King County. The District operates three comprehensive high schools, an alternative high school, four middle schools and 16 elementary schools. It also sponsors an early childhood center for regular and special education preschool and kindergarten students.

An elected, five-member Board of Directors oversees the District. The Board appoints management to oversee the District's daily operation as well as its approximately 2,550 employees.
