

WHAT IS TITLE I?

Title I is a federal education program that supports students experiencing economic instability throughout the nation. Funds are distributed to schools based on the number of students who qualify for free or reduced lunch. The funds can be used for staff, programs, and resources that accelerate the academic achievement so that all children can meet or exceed state and federal levels of performance. In CVSD, our Title I schools are designated as “school-wide” programs. This means that all children in the school are eligible to receive the services provided through Title I funds, regardless of their free or reduced lunch status.

This brochure contains information that outlines how families, school staff, and students will share in the responsibility for improved student academic achievement and the means by which the school and families will build and develop partnerships to help students achieve the State's high standards.
