School, Parent, and Family Engagement Policy

- 1. Alexandria Middle Magnet School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:
 - a. Quarterly Stakeholder meetings where parents and community members are invited via Google Meet.

- b. At the beginning of the school year, we will meet with parents and other stakeholders. During this meeting, parents will receive information about the school's Parent and Family Engagement Plan and will be informed of their parental right to be involved in the planning and development of the plan through meetings, surveys, and questionnaires.
- c. The plan will be sent home with students at the beginning of the school year.

- 5. Alexandria Middle Magnet School, will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - a. Scheduling meetings during teachers planning time.
 - b. Providing two-way communication through the Remind App.
 - c. Supplying parents with teachers' email addresses to foster two-way communication.

- 6. Alexandria Middle Magnet School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - a. Mailing scores to the parents along with the Parent Guide to the LEAP 2025 student reports.
 - b. The numbers listed on file will be contacted for any returned mail.
 - c. Scores may also be picked up from the school for parents who opt to do so.
- 7. Alexandria Middle Magnet School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not certified in the area which he/she teaches by:
 - a. The school will send home a right to know letter informing parents of their rights to inquire about their students scores or teachers current certifications.
 - b. Teacher specific right to know letters will be sent home within the first 9 weeks of school.
- 8. Alexandria Middle Magnet School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph
 - · the state's academic content standards,
 - · the state's student academic achievement standards,
 - · the state and local academic assessments including alternate assessments,
 - · the requirements of Part A,
 - · how to monitor their child's progress, and
 - · how to work with educators:

- 9. Alexandria Middle Magnet School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - a. The school will host a literacy night and LEAP prep night to provide parents with resources to assist parents in improving student performance in Math, ELA, Social Studies, and Science.
 - b. Posting "how to" videos on the school's social media page and website as evidenced by parent's needs.
- 10. Alexandria Middle Magnet School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in

how to implement and coordinate parent programs and build ties between parents and schools, by:

- a. Hosting regular meetings where parents express their needs and types of information desired concerning their students educational and behavioral performance.
- b. The school will encourage personnel to communicate regularly via email or phone with parents to receive their input on types of communication and actions to build an effective relationship with their students.
