A. General Clarifications

B. Clarifications and Additions to Work Scopes

1. With direction from the district Contractors will not need to provide boxes for the project. Contractors will not be responsible for boxing loose contents but will still be responsible for transporting contents to the Gym or Cafeteria in areas marked in Red on the plans. Some contents will be left in mobile furniture such as media center book stands. Items should be moved in a way not to disturb or damage contents.

C. RFI Responses

Q: Contractors should provide boxes to the red areas only as stated in pre-bid walk through. However if the green areas are getting new furniture, I would imagine we need to provide them some boxes to empty the current furniture (free-standing desks, cabinets, etc.) before we arrive and take it away?

A: The District has decided to remove providing boxes from the project all together. There was a significant amount of boxes remaining from the moving project last summer.
