REGULAR MONTHLY MEETING TUESDAY, DECEMBER 15, 2015

The St. Bernard Parish School Board met in a Regular Monthly Meeting on Tuesday, December 15, 2015 at 6:00 p.m. in the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were, Dr. Hugh C. Craft, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Mr. William H. Egan, Mr. Clifford M. Englande, Mrs. Katherine K. Lemoine, Mrs. Diana B. Dysart, Mr. Ronald J. Nicosia and Mr. Sean K. Warner. Dr. Henderson Lewis, Jr., and Mr. Joseph V. Long were absent.

No one wished to address the Board under Community Concerns on the agenda.

Dr. Craft began with the agenda and welcomed Mr. Albert Carey to present an update on the construction of the Accessory Building being built at Chalmette High School. Mr. Carey noted that the slab is completed and the drainage is complete. The steel and metal used to actually construct the building is expected on January 4th.

Mr. Carey addressed all questions and concerns. Dr. Craft thanked Mr. Carey for his presentation.

On motion from Mr. Warner with a second by Mrs. Dysart, the Board voted unanimously by a roll call vote of the members present to incorporate the report of the December 8, 2015 General Committee Meeting into the minutes of the December Regular Monthly Meeting.

GENERAL COMMITTEE REPORT TUESDAY, DECEMBER 8, 2015

The St. Bernard Parish School Board met as a Committee of the Whole on Tuesday, December 8, 2015 at 6:58 p.m. in the Board Room of the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Members present were; Dr. Hugh C. Craft, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Mr. William H. Egan, Mr. Clifford M. Englande, Mrs. Katherine K. Lemoine, Mrs. Diana B. Dysart, Dr. Henderson Lewis, Jr., Mr. Joseph V. Long, Sr., Mr. Ronald J. Nicosia and Mr. Sean K. Warner.

Dr. Craft opened the meeting by noting that due to the late start of the General Committee Meeting, the first presentation on the agenda, Update on the Chalmette High Accessory Building, will be deferred to the Regular Monthly Meeting on December 15, 2015. Dr. Craft then turned the meeting over to Dr. Lewis for the next agenda item.

Dr. Lewis as Education Committee Chair welcomed Mrs. Lawrason, Assistant Superintendent, to present the next agenda item regarding an update of the Believe and Prepare Teacher Preparation Program. Mrs. Lawrason explained that through a state offered opportunity last year the St. Bernard Parish School District became a designated entity to offer an alternate certification program in teaching. Mrs. Lawrason provided the outline shown

below as an update of the School District's Believe and Prepare Program.

UPDATE ON THE DISTRICT'S ALTERNATE CERTIFICATION PROGRAM

2014-15 – Inaugural Year

- Initial certification areas included: elementary, physical education, middle school science and math, high school math, and special education
- 11 candidates in year 1
- Each of the 11 continues to work for us
- Program costs paid through \$125,000 grant

2015-16

- Received permission from the state to add middle and high school English, PK – 3 (early childhood), biology, and business education as initial certification areas
- 25 candidates currently in the program; have reached program capacity
- Requesting permission from the state to provide "Add-on" certification in the areas of mild/moderate special education and significant disabilities
- District received 2 grants, each for \$50,000, to continue our work in this area

Two other parishes have opted to follow our lead, Ascension and Caddo. Ms. Voitier or Mrs. Lawrason have presented on 4 occasions at statesponsored meetings about our program; we also are members of the state's leadership team for Believe and Prepare, along with the Ascension and St. Charles Parish Superintendents, 3 university representatives, and a Board of Regents representative. At the request of the state BP staff, we also have met with representatives of the Schusterman Foundation, a major funding partner with the state for BP activities.

Program requirements:

- A vacancy for which no fully certified, effective teacher is available
- A Bachelor's Degree from an accredited university with a cumulative GPA of 2.5 or higher
- Passing scores on PRAXIS I and PRAXIS II (content area)
- A principal has requested that an individual who meets the above criteria be added to his/her staff to fill that vacancy

All questions and concerns of the Committee were addressed by Mrs. Lawrason. Dr. Lewis thanked Mrs. Lawrason for her presentation.

Mr. Englande as Executive Committee Chair presented a resolution regarding a request from the School Board to the Louisiana State Department of Education to present to School Systems across the state the test items and testing results to school districts prior to the end of the school year.

Dr. Craft moved to recommend to the Board to approve the Resolution to the Louisiana State Department of Education regarding timely return of test results and test items. Seconded by Mrs. Dysart, the motion passed unanimously by a roll call vote of the members present.

Mr. Englande continued on with Executive Committee business by welcoming Mrs. Lawrason back to present the Personnel changes for the month of December. Mr. Englande thanked Mrs. Lawrason for her presentation.

Mr. Englande continued with Executive Committee business by welcoming Mrs. Lawrason, Assistant Superintendent to discuss the adoption of the 2016 through 2017 School Calendar. Mrs. Lawrason explained that the three choices being shown to the Committee at this time have already been reviewed by all full time employees. She stated that one main difference between the choices is the presence of a fall break. The other change is concluding the school year before Memorial Day so that families can be off for that holiday. Mrs. Lawrason also mentioned that state testing dates have not been announced at this time, so any choice made may have to be revisited if state testing dates conflict. The vote by the employees shows their desire to adopt Option 2. Mrs. Lawrason stated the Administration recommends the adoption of Option 2 and asks that the Committee recommend its approval to the full Board.

On motion of Dr. Craft, seconded by Dr. Lewis, the Committee voted unanimously by a roll call vote of the members present to recommend the adoption of Option 2 of the 2016 - 2017 School Calendar to the full Board.

Mrs. Lemoine as Finance Committee Chair welcomed Mrs. Blum to present the next agenda item. The agenda item concerned bid tabulations from the recent Paper, Cleaning and Custodial Supplies bid for the period of January 1, 2016 to June 30, 2016. On motion of Dr. Craft, seconded by Mr. Warner, the Committee voted by a unanimous roll call vote of the members present to recommend to the Board to approve the lowest bid on each item of the Paper, Cleaning and Custodial Supplies bid tabulation for the period of January 1, 2016 to June 30, 2016.

Under Superintendent's recommendations Ms. Voitier asked that parents and the public try to attend upcoming School Christmas Programs and of course the Christmas Program at Docville on Saturday, December 12th.

On motion of Mr. Campbell, seconded by Mr. Egan, and passed by a unanimous voice vote of the members present, the meeting was adjourned.

Ms. Voitier next appeared to present the Personnel changes for the month of December 2015.

As recommended by the Committee, Mrs. Dysart moved to approve the Resolution regarding the earlier return of test results and test items that are administered to students in the spring. The motion was seconded by Mr. England and passed by a unanimous roll call vote of the members present. Dr. Craft read the resolution aloud so that the content can appear in the Regular Monthly meeting minutes.

Resolution

Whereas School Leadership Teams, each summer, spend time studying student achievement data trends for the purposes of determining the effectiveness of instructional delivery and setting school goals for the coming school year; and

Whereas student achievement data is also used in scheduling students for accelerated, honors, and remedial class opportunities and is used, in some cases, to determine grade placement; and

Whereas spring student achievement scores are no longer returned to districts prior to the end of the school year and, instead, are delivered in October – long past the start of the school year; and

Whereas the ability for teachers and administrators to have the opportunity to review actual test items included in state assessments would provide specific evidence of how Louisiana grade level standards are interpreted by those who are constructing the assessments; now be it therefore

Resolved that the St. Bernard Parish School Board respectfully requests that the State Department of Education structure its state-wide testing program in such a manner as to return aggregated as well as individual student test results to school districts prior to the end of the school year; and be it further

Resolved that the Department also release spring test items after each test administration so that there is transparency in the interpretation of Louisiana grade-level standards by assessment contractors and teachers, therefore, may be better prepared to provide students with the specific skills they need in order to meet successfully the standards set forth for their grade levels.

With a recommendation by the Committee, Mrs. Asevedo moved to approve Option Two (2) as the 2016 - 2017 School Year Calendar. The motion was seconded by Mrs. Lemoine and passed without objection by a roll call vote of the members present.
