

## REGULAR MONTHLY MEETING NOVEMBER 15, 2016

The St. Bernard Parish School Board met in a Regular Monthly Meeting on Tuesday, November 15, 2016 at 6:00 p.m. in the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were, Mrs. Diana B. Dysart, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Dr. Hugh C. Craft, Mr. William H. Egan, Mrs. Katherine K. Lemoine, Mr. Clifford M. Englande, Dr. Henderson Lewis, Jr., Mr. Joseph V. Long, Mrs. Judy Nicosia and Mr. Sean K. Warner.

On a point of privilege, Mrs. Dysart wished Mr. Carl Gaines Congratulations from the entire Board on his recent successful election for him to represent District 10 on the School Board. Mrs. Dysart noted that Mr. Gaines would be sworn in to his post at the next School Board meeting. Mr. Gaines, who was in the audience, thanked the Board and Mrs. Dysart for the welcome and stated he was privileged to represent District 10.

Mrs. Dysart next thanked Mrs. Judy Nicosia for her service in representing District 10 since the passing of her husband, Mr. Ronald J. Nicosia in February of this year. Mrs. Dysart has noted that Mrs. Nicosia has been an asset to the Board and she stated that it has been an honor and a privilege to serve with her during this time. Mrs. Dysart next presented Mrs. Nicosia with a plaque as a remembrance of her time on the Board. Mrs. Nicosia stated that it was her honor and pleasure to serve in her husband's place. Mr. Englande also thanked Mrs. Nicosia for her service on the Board and for the service she provides in the community besides on the School Board. Ms. Voitier and Dr. Craft both echoed those sentiments and thanked Mrs. Nicosia for her invaluable service.

No one wished to address the Board under Community Concerns on the agenda.

Dr. Lewis moved to incorporate the report of the General Committee Meeting into the minutes of the November Regular Monthly Meeting. Seconded by Mrs. Asevedo, the motion passed unanimously by a roll call vote of the members present.

## GENERAL COMMITTEE REPORT TUESDAY, NOVEMBER 8, 2016

The St. Bernard Parish School Board met as a Committee of the Whole on Tuesday, November 8, 2016 at 6:00 p.m. in the Board Room of the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Members present were, Mrs. Diana B. Dysart, President, Mrs. Darleen P. Asevedo, Dr. Hugh C. Craft, Mr. William H. Egan, Mr. Clifford M. Englande, Dr. Henderson Lewis, Jr., Mrs. Judy W. Nicosia and Mr. Sean K. Warner. Mr. Donald D. Campbell, Mrs. Katherine K. Lemoine and Mr. Joseph V. Long, Sr. were absent.

Mrs. Dysart began the meeting by recognizing that today would have been Mr. Ron Nicosia's birthday and then also mentioned that his wife, Judy Nicosia also recently had a birthday on November 4th. Mrs. Nicosia thanked everyone for the birthday wishes.

Mrs. Dysart began the meeting by welcoming Mrs. Alex LaPres Schneider to present Super News. Alex first highlighted some district wide events that will occur during the next month, those include the Louisiana Philharmonic Orchestra and the Christmas in New York production, both at the Chalmette High Cultural Arts Center. She also reminded the Committee Members to look at school websites to view the dates of the school specific holiday productions. At this time she presented the most recent Super News production which highlighted Catherine Randall as a Milken Educator award recipient, the Tech Show and Robin Hood Productions at Chalmette High, Homecoming at CHS, Boo at the Barn, Valero Refinery's contribution to Special Olympics, teacher features, art and music grant awards, red ribbon week and finally the announcement of Teachers of the Year for each school. Mrs. Dysart and the Committee thanked Mrs. Schneider for her presentation.

Dr. Lewis, as Education Committee Chair, presented the next agenda item regarding an update on Performance Plus. Mr. Conrad Browne, Curriculum Coordinator, presented this update to the Committee. He began by opening the Performance Plus software for the Committee to view and explained that this software is available to every classroom teacher. Mr. Browne explained that this program assists teachers in utilizing student data to make quick decisions on student performance in the classroom. By allowing teachers to use pre-created benchmark tests for students in class, then running answer sheets through a test answer scanner, results of student tests are recorded and analyzed as to the student's proficiency in those benchmark skills. These test results can be broken down to determine the percent of students who scored proficient, the grades earned on the test and can even compare the test results to earlier testing of students to determine improvement levels. Mr. Browne stated that this program puts a very powerful tool into teacher's hands to assist in the data driven environment education lives in. After Mr. Browne addressed all questions, Mrs. Dysart thanked him for his presentation.

Dr. Craft addressed the next agenda item as chair of the Executive Committee. He welcomed Mr. Granberry to present the personnel changes for the month of November. Mrs. Dysart thanked retiree Carol Beaubouef for her dedication and service. Dr. Craft thanked Mr. Granberry for the personnel review.

Mr. Englande next welcomed Mr. David Fernandez, Finance Manager, to present the revised 2016 – 2017 General Fund and Special Revenue Fund budgets. Mr. Fernandez noted that the changes in the General fund reflect year end encumbrances and fund balances; the only other change current MFP and current staffing. Mr. Fernandez pointed out that the changes to the Special Revenue Funds reflected the final amounts awarded for these programs.

Mr. Warner moved to recommend to the Board to approve the revisions to the 2016 – 2017 General Fund and Special Revenue Fund Budgets. Seconded by Dr. Lewis, the motion passed unanimously by a roll call vote of the members present.

Mr. Englande allowed Mr. Fernandez to also present the bid tabulation for Spices and Seasonings (Class 2), Cereal, Dried Beans and Crackers (Class 3), Frozen Foods (Class 5), Meat and Meat Products (Class 6), Poultry and Eggs

(Class 7), Seafood Products (Class 8) and Canned Goods (Class 9) for the period of January 1, 2017 to June 30, 2017. Dr. Craft moved to recommend to the full Board the approval of the lowest bidder on each item on the aforementioned bid tabulation. Seconded by Mrs. Nicosia, the motion passed with no objections by a roll call vote of the members present.

Under Superintendent’s Recommendations Ms. Voitier noted that the day had been filled with Professional Development for teachers, Teachers of the Year have been announced and awarded to teachers tomorrow.

Mr. Englande on a point of privilege noted the impressive progress that is taking place on the new Arlene Meraux Elementary School.

Mrs. Dysart asked that Board Members fill out the Superintendent’s Evaluation which is in Board Members folders and she wished good luck to the CHS football team in their attempt to compete in the state playoffs in Zachary, Louisiana.

Mr. Warner asked Ms. Voitier for information about the Blue Ribbon task force to review tax policies for the state of Louisiana and the recommendations that are coming from that.

On motion of Dr. Craft, seconded by Mrs. Asevedo, and passed by a unanimous voice vote, the meeting was adjourned.
