

## GENERAL COMMITTEE REPORT TUESDAY, MAY 10, 2016

The St. Bernard Parish School Board met as a Committee of the Whole on Tuesday, May 10, 2016 at 6:00 p.m. in the Board Room of the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were, Mrs. Diana B. Dysart, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Dr. Hugh C. Craft, Mr. William H. Egan, Mrs. Katherine K. Lemoine, Mr. Clifford M. Englande, Mrs. Diana B. Dysart, Dr. Henderson Lewis, Jr., Mrs. Judy W. Nicosia and Mr. Sean K. Warner. Mr. Joseph V. Long, Sr. was absent.

Mrs. Dysart announced the first agenda item, the recognition of the National Academic Games Team. Coach Melinda Hall, introduced team members and showed the trophies they won to the Board. She then expressed her gratitude to the parents, coaches and especially Chalmette Refinery – PBF Energy for their generosity in sponsoring the team's trip to the national tournament as well as the awards for local tournaments and shirts for the team.

All the coaches and team members received proclamations from the President of the Board, Mrs. Diana Dysart, for their outstanding achievements at the 2016 Academic Games National Competition in Atlanta, Georgia.

The Middle Division Team was coached by Ms. Gena Asevedo and as a team received 9<sup>th</sup> Place for an individual's performance in Propaganda.

Members of the Middle Division Team are; Grace Bartholomae, Erik Gangi, Ethan Gilchrist, Antony Vu and Leanne Dacula who placed 9<sup>th</sup> Propaganda.

The Coach for the Elementary Academic Games National Team, Melinda Hall, was honored for her success in training her team. As a team they received a 5<sup>th</sup> place in Presidents and 7<sup>th</sup> place in Propaganda. There were also individual awards for 2nd place and a top 20 in Presidents and a 7<sup>th</sup> place Propaganda.

Members of the Elementary Division Team are; Coby Barrow, Austin Boos, Landin Sanborn, who placed in the top twenty in Presidents, Ava Volante who placed 7<sup>th</sup> in Propaganda and Anthony Wei who place 2<sup>nd</sup> in Presidents.

The Senior Division Team was coached by Jillian Chrisman and Canaan West. As a team the Seniors received a 4th place in Presidents, 4<sup>th</sup> Place in Propaganda and 5<sup>th</sup> place in the Sweeps category.

Members of the 2 (two) Senior Division Teams are; Kelsey Billiot, Jermaine Jiles, Riley Loria who placed in the top twenty for Propaganda, Eryn Loria who placed in the top twenty for Propaganda, Kim Tran who placed in the top twenty for Presidents, Austin Billiot who place in the top twenty in On-Sets, Emily Vu who placed 6<sup>th</sup> in On-Sets, Ahmad Alkurd who placed in the top twenty for Presidents, On-Sets and Equations, Kenny Nguyen who placed in the top twenty in Propaganda, Presidents and On-Sets and Danton Vu.

A proclamation was also awarded to attorney Ryan Gregoire recognizing his contribution as a coach to the 2016 Academic Games National Team.

The President of the Board also awarded Ms. Mary Lumetta a proclamation for her dedication as an administrator of the Academic Games Program.

Members of the Board thanked the Parents, students and Coaches for their hard work and all their accomplishments. Chalmette Refining-PBF Energy was also applauded for their financial contribution.

Mrs. Dysart next welcomed Mr. Brant Mitchell of the LSU Stephenson Disaster Management Institute and Mr. John Rahaim of St. Bernard Parish Government who are developing emergency plans for the schools. Mr. Rahaim explained that through a Homeland Security Grant, the Stephenson Disaster Management Institute, (SDMI), was chosen to develop individualized School Emergency Plans. Mr. Brant Mitchell, Director of SDMI, then explained their mission for developing those plans.

Mr. Mitchell explained to the Committee that their mission is to save lives by improving Disaster Management through leadership, applied research and education. He went on to say that this is done by developing a secure online platform that first responders can access in an emergency. The types of information available for first responders would be; maps of the school, notations of door swings, camera locations, utilities, fire extinguishers, entrances, exits, etc. Mr. Mitchell also noted that when meeting with critical players that are available in an emergency (police, fire, ambulance and homeland security), decisions would be made and recorded regarding traffic plans, medical set-up sites, media sites, responder sites and reunification sites. All this research and the decisions made regarding possible emergency events are available to first responders through the online portal anytime it is needed. At this time, Mr. Mitchell notes that 6 of our 11 schools have been studied and are complete with the remainder to be done within the month. Once complete, these plans can be shared, disbursed or accessed via internet by the School Board, fire, police and other pertinent emergency agencies. After all questions and concerns were addressed, Mrs. Dysart thanked Mr. Rahaim and Mr. Mitchell for their work and the presentation.

Dr. Lewis as Education Committee Chair welcomed Mr. Tommie Powell, Supervisor of Child Welfare and Attendance, to review changes to the Guide to Student Conduct.

Mr. Powell presented the changes to the Guide to Student Conduct for the 2016-2017 school year. He addressed all the questions and concerns the committee had regarding these changes.

Mr. Englande moved to recommend to the Board to approve the changes to the Guide to Student Conduct for the 2016 -2017 school year as presented by Mr. Powell. Seconded by Dr. Craft, the motion passed with no objections by a roll call vote of the members present.

The next item on the agenda was addressed by Dr. Craft as Executive Committee co-chair. Mr. Granberry presented to the Committee the Personnel Changes for May 2016.

Mr. Granberry next presented the Committee with the 2016-2017 Personnel Appointments. Mr. Granberry addressed all questions of the Committee.

Mr. Granberry next presented the Personnel Evaluation Plan with a recommendation for no changes at this time. Mrs. Dysart moved to accept the

Personnel Evaluation Plan as presented tonight with no changes. Seconded by Mrs. Asevedo the motion passed with no objections by a roll call vote of the members present.

Mr. Granberry again addressed the Committee with a request to mail Letters of Assurance for substitutes for the 2016-2017 school year. All questions or comments from the Committee were handled by Mr. Granberry.

Dr. Campbell made the motion to recommend to the Board to authorize the Administration to mail the Letters of Assurance. The motion was seconded by Ms. Nicosia and passed by a unanimous roll call vote of the members present.

Dr. Craft next handed the meeting over to the Insurance Committee Chair, Mr. William Egan. He welcomed Mr. Hugh Harlton, Purchasing and Insurance Coordinator and Mr. Richard Clements, our agent of record from Clements Insurance, to present the Administration's request for permission to renew flood insurance. Mr. Harlton presented the worksheet that indicated the prices for each building for the flood insurance stating that the St. Bernard School board is required to maintain maximum flood insurance available from the National Flood Insurance Program on all buildings.

A motion was made by Mr. Warner to recommend to the Board to accept the Administrations recommendation regarding flood insurance coverage for 12 months beginning May 31, 2016. Seconded by Mrs. Lemoine, the motion passed unanimously by a roll call vote of the members present.

Mrs. Lemoine as Finance Committee chair next introduced Mr. Fernandez to present the Proposed Budgets for the 2016-2017 General Fund and Special Revenue Funds.

Mr. Fernandez went over each of the highlights of the proposed General Fund and Special Revenue Funds budgets and answered all the committee's questions.

A motion was made by Dr. Craft to recommend to the Board to approve the 2016-2017 General Fund and Special Revenue Funds budgets . The motion was seconded by Mrs. Nicosia and passed unanimously by a roll call vote of the members present.

The next agenda item was addressed by Mr. Hugh Harlton regarding the auction for sale of used buses. All buses were sold to the highest bidder.

With a motion from Dr. Lewis and a second by Mrs. Dysart, the Committee voted by a unanimous roll call vote of the members present to recommend that the Board accept the high bid associated with the sale of each used bus.

Mrs. Lemoine continued with Mr. Harlton who stood in for Mrs. Joni Blum, Manager of School Food Services, to present the bid tabulation for Spices and Seasonings (Class 2) Cereal, Dried Beans and Crackers (Class 3), Frozen Foods (Class 5), Meat and Meat products (Class 6), Poultry and Eggs (Class 7), Seafood Products (Class 8) and Canned Goods (Class 9) for the period of July 1, 2016 through December 31, 2016. Mr. Harlton stated that the Administration recommends the low bid for each item as indicated on the

With a motion from Mr. Warner, seconded by Mr. Campbell, the Committee voted unanimously by a roll call vote of the members present to recommend to the Board to approve the Administration's recommendation of going with the low bidder as indicated on the spreadsheet of bids received for Spices and Seasonings (Class 2) Cereal, Dried Beans and Crackers (Class 3), Frozen Foods (Class 5), Meat and Meat products (Class 6), Poultry and Eggs (Class 7), Seafood Products (Class 8) and Canned Goods (Class 9) for the period of July 1, 2016 through December 31, 2016.

Next Mrs. Lemoine allowed Mr. Harlton to present the Administration's request to approve the bid tabulation for Milk and Milk products for July 1, 2016 through June 30, 2016.

With a motion by Dr. Craft, seconded by Dr. Lewis, the motion passed unanimously by a roll call vote of the members present to recommend to the Board to approve the low bidder on the bid tabulation for Milk and Milk products for July 1, 2016 through June 30, 2017.

Mrs. Lemoine next allowed Mr. Harlton to present the Administration's request to approve the bid tabulation for Bread and Bread products for July 1, 2016 through June 30, 2017.

With a motion by Mr. Campbell, seconded by Mrs. Asevedo, the motion passed unanimously by a roll call vote of the members present to recommend to the Board to approve the low bidder on the bid tabulation for Bread and Bread products for July 1, 2016 through June 30, 2017.

Mrs. Lemoine next welcomed Dr. Charles Raviotta, Curriculum Supervisor, to present a Head Start request to approve the expenditure of a Cost of Living increase. Dr. Raviotta appeared in the hopes of having the COLA increase of \$14,678.00 being offered by our federal partners to be added to the Head Start Supplies budget.

With a motion by Dr. Lewis and a second by Mr. Englande, the Committee voted unanimously by a roll call vote of the members present to recommend to the Board to approve the Administration's request to add the \$14,678.00 COLA increase offered by Head Start to the local Head Start Supplies budget.

Under Superintendent's Recommendations Ms. Voitier reminded everyone that before the Regular Monthly Meeting on May 24, 2016 there will be a Public Hearing regarding the 2016 – 2017 General fund and Special Revenue Funds budgets. She noted that there will also be recognition of the annual financial awards that are to be bestowed upon the school system. She also noted that on the agenda there will be an item addressing the consideration and action taken with respect to adopting a resolution providing for canvassing the returns and declaring the result of the special election held in School District No. 1 of the Parish of St. Bernard, State of Louisiana, on Saturday, April 9, 2016 to authorize the levy of a special tax therein. Mrs. Voitier also reminded everyone about the Chalmette High School Graduation on Thursday, May 12, 2016. She also encouraged everyone to check school calendars and attend the many end-of-year celebrations that will be taking place.

Mrs. Dysart thanked the many people and organizations that gave scholarships to students at the recent High School Awards night.

There being no further business to discuss and on motion of Mrs. Asevedo, seconded by Mr. Campbell, and passed unanimously by voice vote, the meeting was adjourned.

**#6 Due Process, Procedures for Suspension and Expulsion Hearings- Page 24*****2015-16 Guide states:***

When an expulsion recommendation is upheld by the superintendent or his designee, middle and high school students are required to attend C. F. Rowley Alternative School for a designated period of time. The students must successfully complete a behavioral program in order to return to their district school. Students who successfully complete the C. F. Rowley Alternative School program and return to their district school will not have the expulsion appear on their school record. However, if a parent or student refuses the services of C.F. Rowley Alternative School or if a student is denied attendance, his or her expulsion will become a permanent part of his or her school record. All students who are required to attend C.F. Rowley Alternative School must successfully complete the behavioral program before returning to any school in St. Bernard Parish.

**Add... 2<sup>nd</sup> Paragraph**

**If a student withdraws for any reason from C.F. Rowley Alternative School and/or leaves St. Bernard Parish without successfully completing the program and returns to the parish, the student will automatically be enrolled at C.F. Rowley to complete the behavioral program in order to be eligible to return to their district school.**

**2016-17 Change to:**

When an expulsion recommendation is upheld by the superintendent or his designee, middle and high school students are required to attend C. F. Rowley Alternative School for a designated period of time. The students must successfully complete a behavioral program in order to return to their district school. Students who successfully complete the C. F. Rowley Alternative School program and return to their district school will not have the expulsion appear on their school record. However, if a parent or student refuses the services of C.F. Rowley Alternative School or if a student is denied attendance, his or her expulsion will become a permanent part of his or her school record. All students who are required to attend C.F. Rowley Alternative School must successfully complete the behavioral program before returning to any school in St. Bernard Parish.

If a student withdraws for any reason from C.F. Rowley Alternative School and/or leaves St. Bernard Parish without successfully completing the program and returns to the parish, the student will automatically be enrolled at C.F. Rowley to complete the behavioral program in order to be eligible to return to their district school.
