Bidders and other interested parties may attend the bid opening which will be held at the time aforementioned.

The work to be performed under this contract consists of all labor, tools, and permit acquisition to accommodate the installation of an owner-furnished scoreboard at the J. Birney Crum softball field, all associated foundations and utilities, and all other associated work shown and/or reasonably implied.
