

GOOGLE APPS PERMISSION FORM

The Beaverton School District utilizes Google Workspace for Education Fundamentals for students and staff. The Google Workspace site is located at this web address and lists the Google applications provided: https://edu.google.com/intl/ALL_us/products/workspace-for-education/editions/. The Beaverton School District may use any or all of the applications provided by Google Workspace for Education Fundamentals.

Access to some other applications used in the Beaverton District rely upon the Beaverton School District Google Workspace for Education Fundamentals account and are not available unless the student has a Google Workspace for Education Fundamentals account (ex. Canvas and Dreambox). A list of applications that could use the google student login is available at: https://sdpc.a4l.org/district_listing.php?districtID=4074.

Technology use in the Beaverton School District is governed by federal laws including:

Children's Online Privacy Act (COPPA)

COPPA applies to commercial companies and limits their ability to collect personal information from children under 13. By default, advertising is turned off for Beaverton School District's presence in Google Workspace for Education Fundamentals. No personal student information is collected for commercial purposes. This permission form allows the school to act as an agent for parents in the collection of information within the school context. The school's use of student information is solely for education purposes.

Family Educational Rights and Privacy Act (FERPA)

FERPA protects the privacy of student education records and gives parents the rights to review student records. Under FERPA, schools may disclose directory information (See Board Policy JOA) but parents may request the school not disclose this information. Parents are provided the opportunity annually to opt out of disclosing their student's directory information on the District's Enrollment Form.

Guidelines for Responsible Use of Google Apps for Education by Students:

- A. **Official Email Address:** All students will be assigned a login name and email account using the format BSDStudentID@bsd48.org. This will be considered the student's official BSD email address until such time as the student is no longer enrolled.
- B. **Prohibited Conduct:** Please refer to Board Policy IIBGA, Administrative Regulation IIBGA-AR, and the Student Family Handbook.
- C. **Access Restriction:** Access to Google Workspace is considered a privilege. The District maintains the right to immediately withdraw access and use of these tools when there is reason to believe that violations of the law or District policies have occurred.
- D. **Security:** The District cannot and does not guarantee the security of electronic files located on Google systems. Although Google does have content filters in place, the District cannot assure that users will not be exposed to unsolicited information.
- E. **Privacy:** There is no expectation of privacy for electronic resources accessed through the district network or in resources provided by using a Beaverton School District account. The District reserves the right to access the BSDStudentID@bsd48.org Google systems and other digital resources at any time, including current and archival files of user accounts.
