Hot Topics in the NPA/S World for 24/25

- CDE certification for NPA providers is essential in order to utilize Special Education funding for services. SELPA is only able to support the creation of SEIS accounts for CDE certified providers in an effort to align with best practice and appropriate funding model.
- Transfer of student & billing dates for District of residence changes. Date of residential change vs. date of enrollment vs. start date at NPS.
- New [Addendum to the Master Contract](#) effective 11/4/24.
 - 1:1 aide day charge for up to 16 absences for student (8 per semester).
 - Charging for contracted staff to attend IEPs at their hourly rate.
