VI. SUPERINTENDENT'S REPORT

- 1. Presentation on Board goal #1 Academic Program and Student Achievement
 - Develop a more vibrant music/arts/theater program

Mrs. Meyer and Dr. Chenaille presented an update of the Music and Arts program. Mrs. Meyer reported that by utilizing COVID funds the school was able to provide students with new instruments for the general music program in hopes to increase enthusiasm and improve performances. She also mentioned that our elementary band instructor created a spreadsheet to include details on our instruments including; brand, condition, repair history, and a replacement schedule. This will allow us to plan for any future replacements and help control expenses. Mrs. Meyer was excited to report the successes of the last two musicals and hopes to add this great event annually. Mrs. Meyer's wish for future plans is to display an elementary art gallery and form a collaboration of the elementary choir with M/HS choir. Dr. Chenaille presented the results of the three surveys

that were conducted last year from current and former musician and reported great feedback which will help develop new curriculum, possibly adding General Music 6, Piano, and Ukulele courses. She stressed how program development is so important and hopes this will help with the performance gaps within grade levels. The survey also revealed a large interest in extracurricular activities such as piano lessons, marching band, and pep band. Dr. Chenaille was excited to tell us about ceramics added into art and would like to see a Ceramics class as a new art course which will provide students with a beginning level experience. 2. Draft Budget Guidelines – Mr. Molisani and Dr. Chenaille developed a draft of thirteen budget guidelines for the 2025-26 school year for the Board to review and adopt at the January meeting.

3. Compact Committee Reports – Mrs. Meyer comments that she is very fortunate that her meetings are well attended and the mission of the compact team is to do right by the kids and spark events. She reintroduced her goals; one being to expand volunteer experiences and how to welcome the community back into the school, hosting a curriculum event, and how to get parents involved.
