- 7. Cherokee Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not certified in the area which he/she teaches by:
 - a. Letters will be sent home to parents of students when their child has been taught for four consecutive weeks by a teacher who is not certified in the area which he/she teaches.
- 8. Cherokee Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,

- the requirements of Part A,
- · how to monitor their child's progress, and
- how to work with educators:

(List activities, such as workshops, conferences, classes, both in-state and out-of-state, including any equipment or other materials that may be necessary to ensure success.)

- a. Each grade will have a parent orientation to explain academic content standards, academic achievement standards, and state and local academic assessments.
- b. The school will have a parent meeting to discuss Title I, what it is and how it will serve the students of Cherokee Elementary. Parents will be given information on how to work with educators during this meeting.
- c. Information will be shared with parents on ways to monitor their child's progress during orientation meetings.
