SARC Overview

Additionally, data reported in an LCAP is to be consistent with data reported in the SARC.

Admission Requirements for the California State University (CSU)

Eligibility for admission to the CSU is determined by three factors: (1) Specific high school courses, (2) Grades in specified courses and test scores, and (3) Graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Middle College High School, a collaboration between Lodi Unified School District and San Joaquin Delta College, is located on the Delta college campus and is part of the Lodi Unified School District. The High School opened in the Fall of 2000. Target enrollment is 300 students in grades nine through twelve. The school is accredited by the Western Association of School and Colleges Accrediting Commission for Schools. In 2008, 2011 and 2019 MCHS was named a California Distinguished School and 2015 was named a National Blue Ribbon School.

The purpose of Middle College High School is to provide a supportive, academically challenging environment for high ability

underachieving youth, or youth with circumstances that would hinder their academic performance at a traditional high school. MCHS enables students to experience a high quality college preparatory high school education with direct access to college.
