BOARD POLICY

An employee of the Board must be on duty whenever a school building or school stadium is used by an organization or group

No building is used for any fundraising activity unless the proceeds are for approved charitable, educational,

On days when school is closed because of snow or other calamity, all activities scheduled for that date are canceled or postponed.

Building use is not permitted for private individuals or family affairs.

No group will, under any circumstances, tamper with any electrical, heating, and water controls as well as technology and AV equipment.

The kitchen is not used by any group unless arrangements are made to have one of the regular food service workers present

There is no smoking or alcohol consumption in the building and on the school campus.

The Board reserves the right to require, if it should deem necessary, that groups using the building post a cash bond to cover any damages that might be done to any property, equipment or grounds.

The procedure for use of the football stadium follows the conditions outlined for the use of the buildings. Special emphasis is given to providing sufficient law enforcement protection and adult supervision.

School-sponsored student groups must have a teacher present at the activity. Nonschool-sponsored student groups must have a teacher present or an adult approved by the Superintendent.

Groups which use school premises must possess liability insurance.

Any event of 300 or more people that is not a district sponsored event requires at least 1 special duty officer from Marysville Police or the Union County Sheriff at the renters expense. Proof of arrangement must be presented at the time of submitting the rental application.

Outside rentals with more than 1000 attendees are prohibited.

Rental agreements with OHSAA and long term contracts with other entities may have differing conditions established by the school district.
