2024-25 School Description and Mission Statement

The Clearlake Creativity School is in Clearlake, California, and has served as a regionalized program for the students of Lake County for more than 10 years. The Clearlake Creativity School (CCS) is a program uniquely designed to suit the needs of students from within Lake County who have intensive behaviors and are unable to make adequate academic progress in a general education setting. The NEEDS-SEB (Needs-driven, Equity-focused, Evidence-based, Designed to provide specialized instruction, Sustainable implementation model for Social, Emotional, and Behavioral supports) model is based on a multi-tiered system of supports (MTSS) and a token economy that are meant to improve student behavior, emotional regulation, and academic success. The program consists of 3 stages, and each stage allows the student to earn access to privileges,

responsibility, and freedom similar to that of students in general education. Clearlake Creativity School serves approximately 28 students total in grades 2-12, by strict adherence to Diana Browning Wright 's NEEDS-SEB program, with the goal of students being able to return to their home school once they have mastered the social and emotional skills necessary to be successful.

The Clearlake Creativity School (CCS) believes that the most influential factor in a child's life is his/her parent(s)/guardians and encourages close partnerships with each child and their family. Throughout the year there are many opportunities to become involved with each child's education. Currently, all CCS students hold an IEP (Individualized Education Program) with a primary designation of emotional disability (ED) which means that the parent is a mandatory part of the IEP process. Parents and guardians are encouraged to review daily points with their child, to participate in school events, and to communicate with the CCS team regularly. Each year parents have the opportunity to participate in Back To School Night, a Thanksgiving Feast, a Holiday gathering and graduation ceremonies (mid-year and end-of-year). School Site Council meetings and LCAP engagement meetings also provide additional opportunities for families to voice their concerns and needs and to participate in the school culture. As we move into the future, CCS is excited to create more opportunities for parents and guardians to become integral members of the CCS family.

We also engage in CPI training, training on trauma-informed practices, de-escalation techniques, and we work closely with Behavioral Health to address the needs of our students. Beginning in the 2024-25 school year, certificated and classified staff hold a contract for a minimum of 190 days (10 days beyond the 180 school days) to ensure staff have additional paid time to participate in professional learning.
