WHEREAS, the Bellevue Union School District ("District") maintains the following positions within the classified/management service:

1. **Newcomer Instructional Assistants**
2. **RSP Instructional Assistants**
3. **Kindergarten Instructional Assistants**
4. **Literacy Paraprofessionals**
5. **Bilingual Literacy Paraprofessional**
6. **Student Supervisors**
7. **Office Assistants**
8. **Family Engagement Facilitators**

WHEREAS, due to cause, including lack of work and/or lack of funds and/or for compliance with the seniority requirements of the Education Code, the Board of Trustees hereby finds that it will be necessary to eliminate certain services to the following extent:

1. **Newcomer Instructional Assistants – 1.5 FTE**
2. **RSP Instructional Assistants – 2.8 FTE**
3. **Kindergarten Instructional Assistants – 6 FTE**
4. **Literacy Paraprofessionals – 4.5 FTE**
5. **Bilingual Literacy Paraprofessional – 2.25 FTE**
6. **Student Supervisors – 16 FTE**
7. **Office Assistants – 3 FTE**
8. **Family Engagement Facilitators – 4 FTE**

NOW, THEREFORE, IT IS RESOLVED by the Board of Trustees that as of the end of the 2024-2025 school year the above-referenced classified positions shall be eliminated or reduced by the District be to the extent set forth herein.


BE IT FURTHER RESOLVED that, pursuant to Education Code sections 45117, 45298, and 45308, the Superintendent or Superintendent's designee is authorized and directed to initiate and pursue procedures necessary terminate the employment of classified employees due to the elimination of the above-referenced classified positions.

The foregoing Resolution was passed and adopted by the Board of Trustees of the Bellevue Union School District on January 21, 2025, by the following vote:


