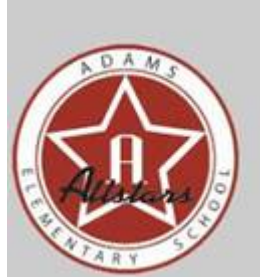

Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Welcome to Adams Elementary, where our All-Stars shine! Our amazing staff works hard daily to support students both academically and social emotionally. Our collaborative teachers follow the Professional Learning Communities model and our commitment to rigorous standards that build on assessment results, which are aligned with the Common Core State Standards and incorporate research-based best practices into the curriculum, instruction, and academic support provided to our Adams All-Stars. As a PBIS school, Adams teachers focus on supporting our students with our two school rules.....Be Kind and Work Hard along with supporting our school wide matrix. Students are celebrated for following Coach John Wooden's Pyramid of Success at monthly flag decks and by receiving lunch bunch certificates.

2024-25 School Description and Mission Statement

We encourage parents to be part of our team and take an active role in the education of their child/children at Adams School. Our Parent Teacher Association (PTA) is continually reaching out to the community to bring enrichment programs and support to ensure our students receive a well-rounded education. PTA supports many school programs, such as: our school play, field trips for all students, character education assemblies and Walk Throughs for our upper grade students. Parents, staff, and community members are actively involved in contributing time, energy, and passion into our school.

Literacy is central to the academic program at Adams School. Our focus is to provide students with core academic instruction with our Wonders curriculum and opportunities for individualized independent reading with our Accelerated Reader program. All students are assessed throughout the year using District Literacy Benchmarks to ensure they are making progress. The results of these assessments are then used to create targeted reading groups from beginning phonemic awareness and phonics instruction to decoding multi-syllabic words. Math, science and social studies are taught using materials and instructional practices aligned to the standards. In addition to teaching the content standards for math we are focusing on the Math Practices where students defend their mathematical reason, use tools, work collaboratively, and more! Adams students in Grades TK-6 have hands-on science lessons focusing on engineering and the Next Generation Science Standards. We are excited to be able to offer Project Lead the Way to all of our students with a focus on engineering.. Technology is important to our team and we have a school wide Chromebook program to enhance learning and it is important to us to teach Digital Citizenship. In Grades 4-6 we offer GATE and to support our STAR rotations we have two full time reading teachers and three hourly teachers. We also are a Title I school and offer the following supports for students who need specialized services; Speech and Language, Psychologist, Specialized Academic Instruction, and house our zone program for students with Autism. All-Stars in Grades 3-6 attend weekly physical education classes with a PE specialist (starting in January 2025, TK-2nd will also receive instruction from the PE Specialist for 30 minutes per week), and all students attend music classes with our Music Specialist who also offers Orchestra to students in Grades 4-6. Our orchestra practices during the school day and plays all over our local community. Teachers also select supplementary instructional materials to meet the specific needs of their students. Individual schools support instruction by providing technology and a library/media center. Internet access is available in the library/media center and in all classrooms. Teachers and administrators have been trained to use technology and the internet as an instructional tool in the classroom. School Facility Conditions and Planned Improvements

ADAMS - 27,840 Classroom Sq. Ft.

This school was built in 1961. There are 15 permanent classrooms, 11 portable classrooms, a multi-purpose room and an administration building. Eleven (11) portable classrooms were constructed between 1991 and 2000. In 2005, 7 of those 11 portables were removed and 4 were modernized. Eight new portables were also placed in 2005. One additional portable was placed in 2008 to add sixth grade to the site and one additional portable added to site in July of 2009.

267 work orders were completed for Adams in the 2023-2024 fiscal year. This site was last inspected on 6/17/24.

In Newport-Mesa Unified School District, plans are reviewed with staff at the beginning of the school year, evaluated and revised December through

January, then submitted to the Board of Education in February. By following this cycle, schools open each August with a fully approved Comprehensive School Safety Plan in place for fall-winter and allows for training and adjustments through mid-year.

Creating and maintaining a safe and orderly environment is essential for learning. We maintain a comprehensive school safety plan and have emergency preparedness coordinators to train and instruct our staff. Our safety plan addresses disaster preparedness, personal characteristics of students and staff, school rules, routines and procedures, and Adams Elementary's physical and social environment. Our school safety team meets to address safety issues for students and employees. Adams Elementary participates in school-wide fire drills every month and intruder and earthquake drills at least two times each year.

The 2024-2025 School Safety Plan was approved by the School Site Council on January 23, 2024 and approved by the Local Board of Education on February 13, 2024. The plan was last updated and reviewed with faculty on August 24, 2024.
