#### 4. 2023-2024 Audit Presentation

Mark Kozloski of Maletta and Company provided a comprehensive overview of The Academy's 2023-2024 audit package, favorably comparing the 2022-2023 audit to the current one. Mr. Kozloski reported accurate findings and appreciated the cooperation and professionalism he received from the personnel in the business office. His management letter recommended continuing ongoing efforts to shift to a more paperless system. The 990 filings for The Academy and the Woodstock Academy Foundation were also reviewed.

# 5. 2024-2025 Budget Status Update

Associate Head of School for Finance and Operations Susi reviewed the detailed revenue report, student medical insurance fees, tutoring fees, department fundraising, and grant income. During the detailed expense report, contracted services, conferences/training, summer curriculum, and agent commission fees were highlighted.
