Rerunning the bond this February

On Feb. 11, 2025, our district will rerun its school construction bond proposal. **In November, our bond measure narrowly missed the required 60 percent supermajority to pass, even though a majority of residents supported it.**

The bond focuses on **addressing growth and overcrowding, replacing aging facilities, enhancing safety and security, and supporting student well-being and success.**

While the projects and \$314 million bond amount remain unchanged, this proposal has a lower tax impact for property owners thanks to reduced interest rates and a growing taxpayer base in our community.

The projects maximize approximately **\$60 million in state construction assistance funds to minimize the costs to our taxpayers.** These funds are only available to school districts after the successful passage of a school construction bond. In addition, school impact fees paid by developers of new homes will also go towards the projects.

The decision to rerun the bond reflects feedback from the 2024 campaign and reinforces transparency and community priorities.

Impact of a second bond failure

Without funding:

- Overcrowding and safety updates will remain unaddressed.
- Necessary major repairs will draw from General Fund dollars—reducing resources for teachers, staff, and student programs.
- Delays will lead to higher construction costs over time—5 percent escalation each year.

BOND COSTS

The proposed 2025 Bond, totalling \$314 million, would cost property owners **\$38** more per **\$100,000** of assessed value, ANNUALLY.

Here's the breakdown of all bond costs from 2025 to 2026 (if the new bond is approved):

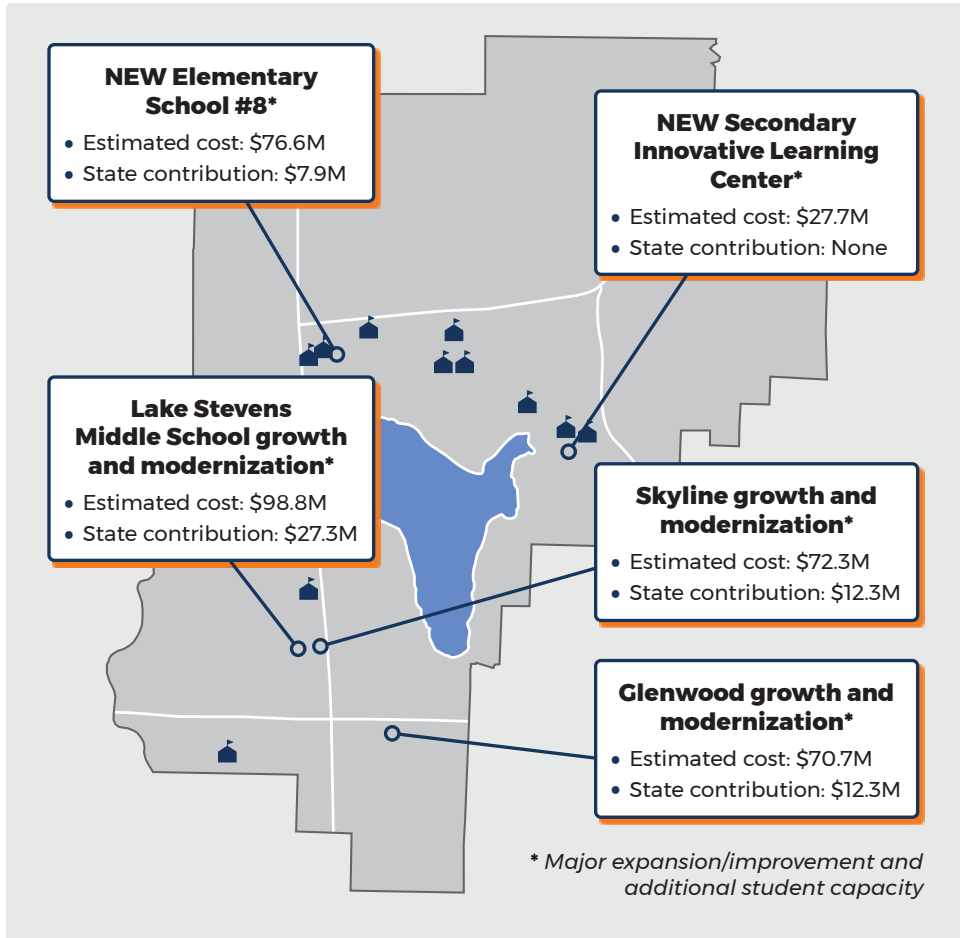

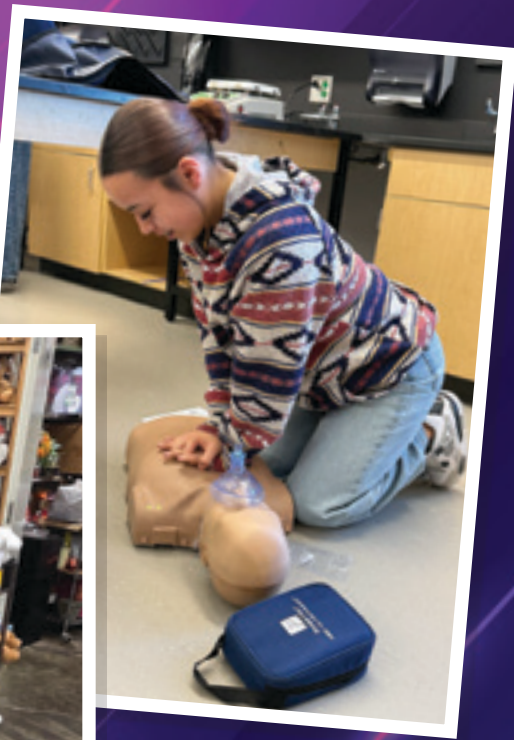
Career and Technical Education in Lake Stevens Schools



More than 65 students from Cavellero Mid High School and Lake Stevens High School gathered for the annual Safeway Takeover hosted by our Lake Stevens DECA chapter! Students stepped into the roles of grocery store employees—gaining hands-on experience across multiple departments and learning the ins and outs of the retail world.

Career and Technical Education (CTE) is essential in preparing Lake Stevens students for high-wage, high-skill, and high-demand careers. With programs spanning our middle schools, mid high school, and high school, CTE provides students with rigorous, industry-aligned courses that explore multiple career pathways. Many classes also offer dual credit opportunities, allowing students to earn college credit while in high school.

CTE programs are supported by dedicated educators and community advisory committees focused on equipping students with the skills and experiences needed for success after high school—whether entering the workforce, military, technical school, or college. We're proud of our students' achievements in CTE and encourage families to learn more about these impactful programs.

Kindergarten enrollment for next school year begins in March

Kindergarten enrollment for the 2025-26 school year begins in March! Each elementary school will share kindergarten information on its website in mid-March and enrollment packets will be available on the school district website and at all elementary schools and at the Educational Services Center.

Children must be five-years-old by Aug. 31, 2025 to enroll in kindergarten for the 2025-26 school year. When enrolling your child, please bring the completed enrollment packet, an official copy of the child's birth certificate, proof of immunization, and proof of residence in Lake Stevens School District. Enrollment is limited to those students who live within school district boundaries.

In mid-August, we'll host our annual three-day Ready for Kindergarten event at each elementary school. Ready for Kindergarten offers a safe and welcoming introduction to elementary school for families and students, relieving many first-day anxieties (for students and their caregivers!). Children must be enrolled in kindergarten in Lake Stevens School District to participate. More information will be shared this spring.

P-5 FAMILY CONFERENCES ARE MARCH 3 TO 6



Family conferences for preschool through fifth-grade are Monday, March 3 through Thursday, March 6. Families will receive information about conferences from their child's school or teacher(s).

- Elementary school students will be released 2.5 hours early Monday through Thursday. Lunch will be served at school as normal.
- There will be no preschool during conference week. Middle school students, mid high and high school students have a normal schedule the week of March 3.
- Friday, March 7 is a standard Friday schedule with an 85-minute early release.



Be prepared for inclement weather

When winter weather hits, our top priority is the safety of students and staff. Our district's geography is taken into account when the decision is made. One part of our area may be clear while other areas are struggling with snow or ice.

How the decision to close schools is made

To help make the best possible decision, weather forecasts are monitored throughout the process. District staff members drive the roads beginning at 3 a.m. checking schools and routes that are frequently impacted and report road conditions to the superintendent by 5 a.m. A decision and announcement is made as quickly as possible. This process sometimes changes based on weather conditions.

Information is shared using these communication channels:

- FlashAlert, www.flashalert.net. Local TV, radio and newspapers pull information from FlashAlert. You can subscribe to receive text and email alerts from FlashAlert.
- Social media

- District mobile app
- Email to families
- District website

We do not use our automated calling system for school delays and closures due to weather. If no messages are posted, schools are open and operating on normal schedules.

Delay and closure options

- Schools start on time (no message will be shared).
- Schools start on time with limited bus service or buses on snow routes. Afternoon bus service will also be on snow routes. (See district website for snow routes).
- Schools start two hours late (no a.m. preschool, no out-of-district transportation, no morning Sno-Isle bus).
- Schools are closed (no after school activities, athletics or facility use).
- Options are subject to change depending on weather conditions.

NEW: If a two-hour delay is needed on a Friday, schools will do away with the 85-minute early release and shift to a normal (M-TH) dismissal time.


