## School Facility Conditions and Planned Improvements

Peterson Elementary School was one of the three “triplet” schools built in the 1980s along with Gracey and Reyes Elementary has a radial configuration with interior pods connecting each group of classrooms. The core facilities include central administration offices connected to the multi-purpose/kitchen and library building surrounded by five classroom buildings, one of which is owned and operated by the Merced County Office of Education to serve moderate to severe special education students. In total, the site provides 20 site-built classrooms and 8 portable classrooms, three of which were replaced in 2018 along with a new modular restroom building to serve the site’s enrollment which had grown beyond design capacity. Two additional portables provide YEP (youth enrichment program) student supervision during before and after school hours. In 2018, a large solar array was constructed along the south portion of the campus playfields, affording shade during hot weather. In 2019, interior fixtures and finishes, partitions, and lighting in both sets of student restrooms were upgraded and a digital marquee panel was fitted to replace the manual letter sign. In 2021, classroom technology upgrades were completed in all 28 classrooms. Planned improvements include four new play structures with shade features for preschool and kindergarten as well as primary and upper-grade students. The School Facility Inspection occurred on 12/11/24.

The Merced City School District recognizes parents are their child's first teachers and encourages parents to participate in the educational program of their children. Many opportunities exist for parents to participate in the decision-making process at Peterson Elementary School. Parents elected to the School Site Council advise the administration of the school, and approve the categorical programs budget. A parent from each school site is selected to represent the school as a member of the LCAP PAC. Parents of English Learners may participate in Peterson Elementary School's English Learner Advisory Committee. The English Learner Advisory Committee advises the administration in regard to the English Language Development program and matters relevant to English Learner students. A member of this committee is selected to represent Peterson Elementary School at the District English Learner Advisory Committee. Parents, teachers, and students compose the Parent Teacher Club, which coordinates fundraisers and other school events to benefit the student body and further build the relationship of the school with parents, teachers, and students. Though participation looks different this year due to the COVID-19 pandemic, we are actively exploring ways for parents to stay involved and connected. Common opportunities for parental involvement include Coffee time with the Principal, Back to School Night, Parent-Teacher Conferences, celebrations, awards ceremonies, seasonal events, Open House, academic fairs, extended day displays, as well as student performances. Additional opportunities to participate in community Local Control Accountability Plan (LCAP) forums are shared with the parent population.
