## School Facility Conditions and Planned Improvements

Wright Elementary School provides a safe, clean, and orderly environment for students, staff, and volunteers. The core facilities built between 1947 and 1949 include the first two wings which house the administration offices and health services spaces, original student restrooms, a large kindergarten classroom, and primary grades classrooms. At nearly seventy years old, the large cafeteria/multi-purpose room (MPR) with cooking kitchen and staff lounge flank the frontage of the wonderful neighborhood school. The site now houses students in a total of 18 site-built classrooms and 8 portables. The school has been re-roofed with standing seam metal panels and reflective coating to augment the school's energy efficiency featuring a large solar array that provides playground shade and another lighted solar array that shelters students in the loading zone and landscaped parking lot near a bright digital marquee. In 2018-19, all site-built classrooms and student restrooms were reconstructed and upgraded, bringing them up to date and featuring state-of-the-art VRF (variable refrigerant flow) HVAC systems. The MPR was also completely modernized, including a new HVAC system to replace antiquated swamp coolers, the stage was updated with new lighting and musical instrument storage to augment VAPA programs, a new wheelchair lift was installed, and interior painting, new wall finishes, and new projection equipment was installed to transform the facility into one of the best in the District. Site improvements featured a student loading zone built concurrently under a solar array canopy, construction of new basketball/volleyball courts and an operational services and storage yard to enclose waste dumpsters and mechanical equipment, significant storm-drainage infrastructure to address periodic site flooding, and installation of new ornamental iron security fencing and accessibility improvements along the entire frontage of the school. The project modernized all site-built classrooms, including casework, sinks/drinking fountains, classroom technology upgrades, major modernization and furnishings in the library, campus-wide LED lighting upgrades, and construction of new disabled restroom facilities for both students and staff. In 2019, a new kindergarten play structure with integrated shade features was installed. Planned improvements include the completion of technology upgrades in the portables, a new shaded play structure for preschool and kindergarten student use, and an outdoor learning and dining shelter. Construction of a new permanent special-education services building with restrooms is recommended to replace aged portables. The Facility Inspection occurred on 1/13/24.

The Merced City School District recognizes parents are their children's first teachers and encourages parents to participate in the educational program of their children. Many opportunities exist for parents to participate in the decision-making process at Wright Elementary School. Parents elected to the School Site Council advise the administration of the school, and approve the categorical programs budget. A parent from each school site is selected to represent the school as a member of the LCAP PAC. Parents of English Learners may participate in Wright Elementary School's English Learner Advisory Committee. The English Learner Advisory Committee advises the administration regarding the English Language Development program and matters relevant to English Learner students. A member of this committee is selected to represent Wright Elementary at the District English Learner Advisory Committee. Parents, teachers, and students compose the Parent Teacher Club, which coordinates fund raisers and other school events to benefit the student body, and further build the relationship of the school with parents and students. Though participation looks different this year due to the COVID-19 pandemic, we are actively exploring ways for parents to stay involved and connected.
