## School Facility Conditions and Planned Improvements

While several facility improvements have been completed since 2018, including major re-roofing, new walk-in refrigeration units and operational yard, security fencing, limited student and staff restroom upgrades, and a digital marquee, Sheehy's core facilities (administration, cafeteria/multipurpose room, kindergarten classrooms and play areas) and classroom wings were originally constructed in 1950 and added in 1957 and 1961. Collectively, they are undersized to meet Title 5 compliance standards and adequately serve capacity enrollment. In 2021, the addition of counseling and intervention staff resulted in the construction of confidential office spaces and the provision of new furnishings in one converted portable classroom to provide for such services. Immediate planned improvements to begin in 2022 include reconstruction of the first wing to enlarge and upgrade kindergarten classrooms and play areas/equipment and provision of compliant/adequately sized health services, restrooms, and administration offices with student and parent support spaces. The modernization project will include full upgrades to all 22 site-built classrooms, including the newest wing which was built in 1961. Replacement of major main water service and sewer infrastructure will also occur. Interior finishes, casework, plumbing, lighting, electrical, fire/life-safety systems, classroom technology, accessibility upgrades to paths of travel, student and staff restrooms, HVAC systems, the final phase of major re-roofing, campus-wide lighting, and replacement of obsolete portables with three new portables with plumbing will be completed. The extensive project will also include main frontage and signage upgrades entry access control improvements, and a large metal shelter located between the cafeteria and the library. The shelter will provide shaded areas for both outdoor learning opportunities as well as much-needed space for students to enjoy lunch and new furnishings located under the "Cougar Nutrition Shelter." Improvements for 2020-21 included slurry sealing over the blacktop play area. The Facility Inspection occurred on 8/22/24.

#### 2024-25 Opportunities for Parental Involvement

The Merced City School District recognizes parents as their child's first teacher and encourages parents to participate in the educational program of their children. Many opportunities exist for parents to participate in the decision-making process at Sheehy Elementary School. Parents elected to the School Site Council advise the administration of the school, and approve the categorical programs budget. A parent from each school site is selected to represent the school as a member of the LCAP PAC. Parents of English Learners may participate in Sheehy Elementary School's English Learner Advisory Committee. The English Learner Advisory Committee advises the administration in regard to the English Language Development program and matters relevant to English Learner students. A member of this committee is selected to represent Sheehy Elementary School at the District English Learner Advisory Committee. Parents, teachers, and students compose the Parent Teacher Club, which coordinates fundraisers and other school events to benefit the student body, and further build the relationship of the school with parents and students. Though participation looks different this year due to the COVID-19 pandemic, we are actively exploring ways for parents to stay involved and connected. Common opportunities for parental involvement include: Back to School Night, Parent-Teacher Conferences, celebrations, awards ceremonies, seasonal events, Open House, academic fairs, extended day displays, as well as student performances. Additional opportunities to participate in district-wide Local Control Accountability Plan (LCAP) forums are shared with the parent population.

This school year, MCSD has committed over one hundred days to high-quality staff development, reinforcing our dedication to continuous growth and improvement. These efforts have been carried out across our fourteen elementary schools, four middle schools, thirteen preschools, and the Community Day School, ensuring a broad district-wide impact.
