- **Dr. Johnson welcomed everyone and thanked them for taking time during this busy season.**
- **Review of committee member expectations**
- **Dr. Johnson shared an abbreviated version of the "Our Story" message that was shared at the Town Hall meeting in November to include demographics, goals, and future planning.**
- **J. Jones asked about the cost of the new school and Dr. J reported that currently based on projected cost we have the funds in place to cover the process. Dr. J reviewed the timeline with the committee for the building of the new school and information on the layout as well.**
- **Dr. J shared the renderings for the new school and discussed traffic flow, athletic fields, and layout.**
- **J. Jones reported that seeing the renderings has been helpful in understanding the process.**
- **Question was asked about the public library. It was shared they will be a separate entity once the new school opens.**

- **Dr. J explained Phase 2 of the grant which would add wings on to PCPS and move 4th and 5th grade under one roof.**
- **R. Tipton asked about attendance at BOE meetings. Information was shared on public comment and attendance.**
- **Dr. P shared the equity plan and explanation of its purpose, our need for review by federal guidelines, along with the 3 main components of the plan.**
