## **Kindergarten Readiness in our Community**

The Illinois State Board of Education requires the district to survey all Kindergarten students during the first 40 days of school. This provides a profile of each child's development across four developmental domains: Approaches to learning, social emotional development, language and literacy development and cognition, as well as math.

U-46 has been giving this survey of our Kindergarten students since 2016. Below you will see our most recent KIDS data from the Illinois School Report Card.

#### Using the KIDS data to increase our outcomes:

#### KIDS data:

- Provides aggregated data about early childhood development in our community.
- Helps us see where we need to have more connections and collaborations with our families prior to school enrollment.
- Make decisions about resource allocation and ways we can support our young families in raising strong, kindergarten ready, young learners.
- Helps teachers understand each student's abilities, strengths, and areas of growth.
- Partner with families to support their child's unique learning needs and development.

#### **KIDS Data does not:**

Tell us about Kindergarten instruction or outcomes.





## **Efforts to Increase Kindergarten Readiness in our Community**

**Reduction in preschool class size to 15,** from 17-20, to better meet the needs of our students.

**Rising Kindergarten Summer School Program** to support student success in their transition to kindergarten.

**Revised Kindergarten transition process** and plan for increased support for students transitioning to Kindergarten from the district preschool programs and newcomers to the district.

**Continued partnership with our community day care providers** by providing professional development to help get us all working toward the same goals.

Continued partnership with Elgin Partnership for Early Learning focused on increasing access to high quality early learning and increasing opportunities in non-traditional settings across the U-46 communities.

**Working to increase opportunities for preschool** in the district across elementary schools with Unite 46.





## **District Strategic Plan: Priority 6**

The goal of expanding preschool opportunities is to serve our youngest learners and their families better. There is currently a waiting list for our preschool programs that needs to be remedied. To work toward the goal of reaching as many students as possible, the district will:

- 1. Complete the review and revision of current boundaries.
- 2. Resize elementary buildings.
- 3. Determine which schools have the greatest need and greatest availability to house a preschool wing.
- 4. Adjust budgets needed to support preschool within the buildings.
- 5. Recruit additional preschool teachers and support staff.
- 6. Create an effective community outreach plan to identify students for the expanded preschool offerings.

Establish scaffolded roll-out for PreK across the system and the infrastructure to support seats and facilities.

#### Considerations:

- → Declining Enrollment, due to Decreased Community Birth Rates
- → Building Retirements
- → Unite 46 Efforts
- → Middle School Shift and Facility Needs
- → Available Grant Funding

#### Next Steps:

- → Continue steering committee work
- → Invite community representatives to our steering committee
- → Develop five-year plan with all data points and considerations as aligned with Unite 46 initiative

## **Staff Recruitment and Capacity Building**

#### **Current Efforts:**

- → NIU Cohort of paraeducators currently working on teacher certification, six participants graduating spring of 2024
- → Included in all human resource recruitment activities

#### **Recommendations:**

- → Potential cohort of teachers that are lacking specific credentials
  - Pull credential data of teachers in the district with Early Childhood credentials but missing endorsements
  - Transcripts can be sent to universities for review and to determine next steps
- → Strengthen pathways for high school students in early childhood
