2025-26 Preschool 3 Tier Tuition Assistance Scale

These tiered scholarship funds can only be used towards the cost of a 2.5 hour or 4 hour preschool class.

To receive tuition assistance, we must have a copy of your 2024 W2 form, or 2 recent consecutive pay stubs, for all wage earners in the household.
