### 4. Trustees - Mr. Damon reported:

a. The Brewer School Department applied for and won a two-million dollar Revolving Renovations Grant from the State which, when combined with Federal pandemic funding, will allow for completion of the last phase of renovation at Brewer High School (BHS) that includes modernization of the HVAC system, heating system, and improvements to the building envelope. Additionally, the School District applied for a rare waiver from competitive bidding because half of the BHS project was already completed with a local contractor through Federal pandemic funding, and to begin again with a bid process based on the new State funding could compromise maintaining continuity and work and budget efficiencies based on the prior work. It may also have delayed the work until the summer of 2023, putting off key safety improvements that would benefit and protect students and staff. Now the funding is in place and work will proceed during June, July, and August of 2022.

### 4. Trustees - Mr. Damon reported:

The Brewer School Department applied for and won a two-million dollar Revolving Renovations Grant from the State which, when combined with Federal pandemic funding, will allow for completion of the last phase of renovation at Brewer High School (BHS) that includes modernization of the HVAC system, heating system, and improvements to the building envelope. Additionally, the School District applied for a rare waiver from competitive bidding because half of the BHS project was already completed with a local contractor through Federal pandemic funding, and to begin again with a bid process based on the new State funding could compromise maintaining continuity and work and budget efficiencies based on the prior work. It may also have delayed the work until the summer of 2023, putting off key safety improvements that would benefit and protect students and staff. Now the funding is in place and work will proceed during June, July, and August of 2022.

## CALL TO ORDER

Board Vice Chair Cheryl Fasse called the Zoom meeting to order at 7 a.m.

Motion: To approve the November 16, 2021 minutes as presented.

Lacadie/Ismail Approved without opposition.

## **HEAD OF SCHOOL REPORT**

Dave welcomed questions on the previously distributed Head of School Report. The school is looking ahead to anticipated pandemic related changes – other states are starting to lift mask mandates in schools and the DOE has been meeting with public school superintendents who are actively meeting and discussing easing restrictions.

Dave remarked on international and local recruiting as being on trend or better than pre-pandemic years. He will be meeting with agents in several new countries as part of his participation in a virtual recruiting fair hosted by ICEF the week of February vacation; he has already had several virtual meetings with an educational company in Africa. Typically, about 73% of accepted international students actually enroll. Regarding recruitment of boarding student within the US, American students seeking a boarding school experience are typically looking for a more traditional boarding school with an all-inclusive campus and exclusive programs. Viewbooks are shared with local professionals like real estate agents and physician recruiters so that families new to the area can factor in the educational opportunities available to their families when considering a move the area. It was suggested to also connect with the Chamber of Commerce to promote the school.

#### **FINANCE**

Bill Meier reported on behalf of the Finance Committee and welcomed questions regarding the committee meeting minutes. The Board-approved budget for this year projects a deficit of \$500,000. Three factors have contributed to a likely reduction in this number: (1) both day and boarding enrollment have been a little stronger than was anticipated; (2) the state increased by 4.5% the authorized tuition rate which can be charged for students from towns with school choice, as compared to last year; and (3) expenses are running below budget by about 1% through January. The projected effect is to reduce the annual deficit to between \$200,000 and \$250,000. In other matters, Bangor Savings Bank renewed the school's two lines of credit, extended the revolving loan for the Darling Center for another year, and refinanced the school's primary mortgage, reducing the interest rate to 4.66%, which will save \$13,000 per year in interest expense. The revolving loan is one of two financing instruments for the Darling Center, the other being a commercial loan. The "revolver" is collateralized by pledges receivable, and has a current balance of \$112,000. We expect to liquidate it during this calendar year. In response to a question about the level of spending for student activities and the possible need to increase it in a non-pandemic year, it was indicated that this year's budget already allows for a normal level of activities, although there is still some underspending due to COVID constraints.

## **BUILDINGS AND GROUNDS**

Chair Jim Lacadie welcomed questions on the Building and Grounds minutes. A new point of interest and possible future discussion is that St. John's Episcopal Church may have a building (currently housing offices) available to lease or buy in the future. If and when this materializes, the board will be kept informed.

### **DEVELOPMENT**

Chair Cheryl Fasse invited questions on the minutes. The annual fund is far ahead of where it typically is at this time of year, partly due to a couple of substantial gifts. New fundraisers are expected to be rolled out in the coming months and an expanded alumni event is being planned to coincide with the July 25 Annual Golf Tournament. Cheryl reminded the board that 100% participation from the board in the annul fund is an expectation.

#### **ENDOWMENT**

Chair Kirsten Ismail spoke to the strength of the school's portfolio, still over \$2 million. The committee is exploring the use exchange traded funds (ETFs). New committee members are being sought; please share recommendations with Dave, Matt, or Kirsten.
