# FAMILY & COMMUNITY ENGAGEMENT SPECIALIST, WHOLE CHILD AND COMMUNITY DESIGN

## **Purpose Statement:**

The Family and Community Engagement Specialist, Whole Child and Community Design serves as the county lead in coordinating county staff efforts in designing support for district/site administration to plan, develop, implement, and evaluate authentic community/family engagement strategies. Additionally, the Family and Community Engagement Specialist will serve as a liaison between state, county, district, community, and government agencies that support historically underserved student populations.

### **Diversity Statement:**

## **Essential Functions:**

- Coordinates and collaborates with staff from across the San Diego County Office of Education (SDCOE) to provide coherent and aligned services in support of community/family engagement and education.
- Assists in creating and developing SDCOE's family and community engagement strategy
- Serves as a county liaison to state, county, and district community organizations that support historically underserved/marginalized student populations.
- Organizes and distributes key information and resources to build local educational agency (LEA)
  capacity in family & community engagement through networks, website, and other modes of
  communication.
- Provides guidance to LEAs and family-serving organizations on best practices pertaining to the
  design, implementation, and evaluation of programs, events, and trainings that involve community
  and families in school activities such as parent advisory councils, advisory committees, parent
  education programs, workshops, and social service programs.
- Develops and maintains a repository of best practices, resources, tools, etc. that are disseminated to school districts and family-serving agencies.
- Develops and curates resources for LEAs and school sites in developing a whole-child approach to authentic family and community engagement.
- Provides technical assistance to LEAs and family-serving organizations on best practices for data collection, recruitment, and sustained family and community engagement.
- Analyzes data to determine community/family engagement trends and efficacy of programs and prepares reports as necessary for SDCOE's alignment of services to LEAs and the community.
- Develops and delivers presentations on community/family engagement, involvement practices, and programs, at meetings, conferences, in-services, and workshops.

- Collaborates with SDCOE departments to develop program content and serve on advisory committees in county-wide, state- and federally mandated meetings (e.g. Latinx Advisory, African-American Advisory) regarding required family engagement and involvement practices.
- Identifies and contacts appropriate public and private agencies to develop partnerships and services to students and families.

## **Other Functions:**

• Performs other related duties as assigned for the purpose of ensuring the efficient and effective functioning of the work unit.
