SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. This plan was presented during a parent meeting (8/26) and staff meeting (8/16). This plan was also presented at the Board of Education meeting on 8/30/21. We asked for comments and suggestions at all meetings.

Parents of all subgroups were invited and represented at the parent meeting, along with a Spanish translator to make sure everything was understood. This plan was also presented to our PTSA which has student representation at each meeting. We will continue to engage the stakeholders by seeking input at future PTSA and BOE meetings throughout the school year.

The Shelter Island School District has used funds last year and this year to safely open the school. We were open full time from Pre-k through 12th grade last year. We invested in wash stations, sinks, HEPA air filtration systems, and many different forms of PPE. Most of the funds used through this grant will be used to pay to enhance any learning that was lost during the pandemic. We would like to use this money to pay for enhanced learning programs during the summer time and also address our students with disabilities. Currently, we are identified by the NYSED as a targeted school district mainly due to our students with disabilities state assessment scores. We feel this is where our students will benefit most.

The Shelter Island UFSD plans on using the reserved funds to implement a summer learning program for the 2021-2022 and 2022-2023 school year. We will be cross contracting with SCOPE to provide a two hour program Monday-Thursday for the month of July. Students will have an opportunity to participate in 45 minute math lesson, 45 minute ELA lessons and 30 minute science lesson each day. Integrated throughout the curriculum will be opportunities to address social emotional learning.

The Shelter Island UFSD will be utilizing these funds to purchase two researched based programs for our students with disabilities: Sondag System and EQUALs math program. EQUALs is a multi-sensory math curriculum specifically designed for students with disabilities, K-12. Lesson structure is based on general education math methodologies with differentiation embedded into the lessons, and provided with a resource to support student actions. EQUALs is a complete standards-based mathematics curriculum for students of differing abilities. It is the only program of its kind with an instruction model with proven success demonstrated by a 4-year research study.

EQUALs encompasses:

- pre-readiness math skills for students at any age who need the most basic starting point (e.g. attending to instruction, cause and effect, everyday patterns)
- foundational math skills and concepts found in all mathcontent areas (numbers and operations, measurement,data and probability, algebra, and geometry)
- problem solving throughout every lesson, connected inmeaningful ways

Each lesson maps out a progression of learning from activating and building background knowledge to problem solving, practice, and application. Students are placed in EQUALs Math using the EQUALs Assessment provided in the kit. The assessment covers benchmarks from all five content areas and includes an Attending and Exploring screening tool for students who may need to begin at the most basic level of math instruction.

The Sondag System 2 offers structured, systematic, multisensory reading intervention for intermediate readers in reading levels from third through eighth grade. Each lesson plan uses proven Orton-Gillingham methods to provide effective intervention in small-group settings. Sondag system assessments help determine where to start a student within the system and show student strengths and weaknesses. Pre- and post-tests determine a baseline and track student growth over time.

Let's Play Learn offers structured, systematic, multisensory practice for students in preschool through kindergarten. It is used as a tool to develop foundational reading skills and prevent reading difficulties or as an intervention for those who need to strengthen pre-reading skills. Each lesson plan uses proven Orton-Gillingham methods to provide effective intervention in whole-class and small-group settings.

In addition to purchasing EQUALs and Sondag System programming (Let's Play Learn was previously purchased but no PD was provided to the teachers), the district will provide professional development and coaching to the teachers to support them while using these new programs. The district will also use these funds to pay for substitutes while the teachers are receiving their training.

The Shelter Island UFSD is a small rural school district with a population of 183 students. Of these students, there are 19 students who are classified as students with disabilities, 19 students of color, 13 ELL students, and approximately 54 students come from low income families, There are no students who are homeless, in foster care, or migratory. The vast majority of this grant will be used to fund a summer learning program for students in k-8. We will actually be using more than the 20% reserve required. Our summer program will focus on things such as literacy, math and science but will also have a heavy dose of social and emotional learning. This past summer we had 60% of our eligible ELL students attend the program; 34% from low income families; and 29% of students with disabilities. The summer school coordinator along with the district's bilingual secretary, when needed, reached out to all ELLs, Special Education, and low income families to ensure they had equal assess to the program. Next year, we will include students of color to ensure their participation. This summer we had 10 eligible students of color who could attend the program, however, none of these students attended.

Our Multi-Tiered Support System will over see the implementation of our new programming for math (EQUALs) and literacy (Sondag System 2) to ensure these students will be placed, when appropriate, into these programs. The MTSS will follow the steps outlined in our newly revised MTSS plan as found on our district website under the Parent/Student Use Tab.

Finally, it should be noted that during the 20-21 school year, the Shelter Island UFSD district was in session for the majority of the year for in person learning. There were only eight days of remote learning. Therefore, the student learning for the 20-21 school year was minimally impacted compared to other districts.
