## Dear Parents/Guardians:

The Sayville School District will again transport elementary grade children from their school to a childcare center operated by a municipal or a non-profit organization located within the boundaries of the District. The transportation is available to any child based on District mileage requirements between the school the child attends and the childcare centers which are one-half mile or more for grades K-5. To be eligible for transportation to a childcare center, **your child does not need to be eligible for transportation from home to school.** 

If a parent or guardian wishes to request childcare transportation for the <u>2025-2026 School Year</u>, an application must be submitted to the Transportation Office by <u>April 1, 2025</u>. <u>Based on the current capacities of our buses, we will be unable to accommodate requests received after April 1.</u>

At the present time, there are three centers that qualify for transportation. These centers and grade eligibility for transportation are as follows:

- 1) New Life Community Church Center, 380 Lakeland Avenue, Sayville
- 2) Town of Islip LEAP Program @ Cherry Avenue Elementary School, West Sayville
- 3) SCOPE Program @ Lincoln Avenue Elementary School, Sayville

It is **expected** that transportation will be provided beginning **Thursday, September 4, 2025** for those children who have an approved application form on file. <u>Transportation will not be provided on legal holidays or recesses when public schools are closed.</u>
