## **PRESCHOOL PROGRAM**

### **SCHOOL YEAR 2025-2026**

The Preschool Integrated Program accepts children that must turn 3 (or 4) by June 1, 2025, and must be completely toilet trained prior to entrance into the program. Children who meet the Kindergarten cut-off and will be 5 years of age on or before October 1, 2025, will not be eligible for the preschool program. The program will be instructed by a teacher certified in both general and special education. The class will be supported by a paraprofessional and the program will follow a state required curriculum. The program will be in session from 9:30 am to 2:00 pm five days a week, Monday through Friday, at the Tewksbury Elementary School. Parents are responsible for providing transportation and paying tuition to the Board of Education. The tuition for the 2025-2026 school year is \$8,500.00.

Completed applications must be **submitted in person** with the following documents:

1. Your child's original, raised seal birth certificate.
2. Proof of residency in Tewksbury Township. Three (3) of the following documents are required:
  - a. Deed
  - b. Lease
  - c. Property Tax Bill
  - d. Mortgage Statement
  - e. HUD Form
  - f. NJ Driver's License (with Tewksbury address)

- g. Current Utility Bill (with Tewksbury address)
- h. Voter Registration Card.

Note: Alternate documentation of residency will be considered as required by law.

Applications will be accepted in the Child Study Team Office located at the Tewksbury Elementary School by **appointment only**. Applications are due by **February 28, 2025**.
