PUBLIC PARTICIPATION

This public session is designed for members of the public to speak on items for Board consideration. By law, the Board of Education is under no obligation to respond to public comment. If the Board of Education chooses to respond, it does not waive its right thereafter not to respond. Members of the public are asked to state their name and address for the record. ***Members of the public are requested to keep their comments to a maximum of 5 minutes. **

Cody Castner- 929 Fairview Lake Road- Mr. Castner addressed the school board, congratulating them and the staff for being one of the top-performing elementary schools in the state. He urged board members to actively engage and reflect on their commitment when joining the board. Highlighting his family's deep roots in Stillwater and generational ties to the school, he expressed concerns about issues he feels conflict with the school's values. He raised safety concerns regarding public transportation, citing incidents involving bus drivers from other districts. He emphasized the need for mental health requirements.

Additionally, he questioned the school's opt-out program. Dr. Kochis stated that the opt out program is specifically regarding health curriculum topics. Mr. Castner acknowledged parents' ability to opt their children out of specific lessons in the Health Curriculum. However, he expressed concern about his children, and others, being exposed to individuals who share the ideology from the specific health lessons. He stated he met with legislators to discuss stricter regulations on mental health for bus drivers. He concluded stating the community demands the board take action and put this on the table for discussion.

President Galante read the following statement: The Board is not permitted to discuss personnel and individuals in public; and discriminatory comments not only create legal concerns for the District, but may create personal liability for the public participant. We respectfully request that you refrain from these types of comments during public participation with these comments. Please contact the Superintendent's office if you have any questions.

ADJOURN

Motion made by Mr. DeGroat, second by Mrs. Williver to adjourn at 7:21 pm. A voice vote was taken and unanimously approved.
