Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2024-25 School Safety Plan

The school's safety plan is reviewed and updated yearly. Each staff member is aware of what their role is in crisis situations. A crisis team is in place for individual personal crises as well as natural disasters. A complete copy of the School Safety Plans can be obtained in the Administration Office. The School Safety Plan was reviewed by the School Safety Committee consisting of the Principal, Vice Principal, and Director of School Site Safety in December 2023/January 2024. The plan was approved by the School Site Council in February, 2024. The plan was board approved in March 2024 and posted on the website.

District Statement:

We want our community to be aware of our continued commitment to safety which includes multiple, proactive approaches to fortifying security throughout our schools.

In April and June 2018, we conducted safety reviews of our campuses that resulted in the implementation of enhanced safety measures. These measures vary by school and include enhanced fencing, additional security and counseling personnel, updated surveillance cameras, front entrance modifications, and door locking devices. We also incorporated additional training with the Lancaster Sheriff's Station and revised student, staff and visitor identification processes.

A School Resource Officer is available to the school. In addition to this, we continue to focus on our students' social emotional needs through various programs and counseling outreach, provide safety training to our students and staff, and underscore the importance of vigilance through "See Something, Say Something." Our district and site websites have links to confidential student referral forms, where students and parents are able to submit safety concerns for administration to address.
