About Laurelwood Elementary School:
 Laurelwood Elementary School is a suburban Pre K - 5th Grade school of around 585 students in Santa Clara Unified School District (SCUSD) that opened in 1964. Currently there are 25 general education classrooms and 4 special education classrooms. The campus also includes classrooms to support music, STEAM, PE, after school care, and wellness. The 10 acre campus was modernized during the 2005-06 school year and again in 2017. Staff, parents and students take pride in an orderly and attractive facility. Restrooms for adults and students are ADA-compliant, as well as their are student and adult gender neutral bathrooms available. The attendance area is large, with diverse housing options. Most homes are middle-class,

relatively affluent single-family dwellings, but several apartment complexes are also within our boundaries.

The school climate at Laurelwood is characterized by strong academic performance and a positive atmosphere that focuses on supporting the whole child. Respect, responsibility, and safety create the foundation for building student independence and establishing a caring community of learners and problem solvers. Procedures are established and reinforced school-wide and in each classroom. School-wide expectations are defined for all and staff members embrace Multi-tiered Systems of Support based on the PBIS philosophy.

Laurelwood has a strong and active Parent-Teacher Association (PTA) that helps coordinate a large parent and community volunteer program. Volunteers work in classrooms, on the playground, in the school garden, in the office, and in our copy center on a regular basis. Opportunities to help are also available for special events and field trips. The School Site Council (SSC) and the English Learner Advisory Committee (ELAC) also provide support for the school community.

Laurelwood's mission is to provide growth for every individual, both students and staff, through strong academics, adult professional development, collaboration and social emotional development.

The Laurelwood team envisions a future in which all students reach their highest academic potential while maintaining empathy and compassion for others.

Laurelwood's expansive 10-acre campus provides a welcoming and stimulating environment for students. The school underwent modernizations in 2006 and 2017, ensuring up-to-date facilities. School Facility Conditions and Planned Improvements

General

Santa Clara Unified School District (SCUSD) takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, SCUSD uses a facility survey instrument developed by the State of California OPSC. The results of this survey are available by request made to the SCUSD's Facilities department at (408) 423-2061.

Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Maintenance and Repair

SCUSD maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule

The governing board has adopted cleaning standards for all schools in SCUSD, Board Policy 3514. The policy can be found online at www.santaclarausd.org/BoardPolicies. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance

SCUSD participates in the State School Deferred Maintenance Program to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

Modernization Projects

SCUSD strives to be a model of financial responsibility, making every effort to spend taxpayer dollars wisely. At the same time, ongoing bond programs are necessary in a district this large, with so many students, teachers, and facilities needs. Bond funds allow the District to maintain safe, modern school facilities and bring in updated technology essential to student achievement. Measure B 1997 improvements included new elementary school play structures, new high school science classrooms and outdoor athletic facilities, the major renovation of eleven elementary schools, an ambitious roof replacement program, and two high school performing arts buildings. Measure J 2004 generated funds to modernize buildings and classrooms for middle schools, high schools, and the adult education campus. Measure H 2010 upgraded fire, safety and security systems, renovated and reopened a closed elementary school, installed solar panels to decrease energy costs, purchased the Agnews campus property, and expanded overcrowded schools. Measure H 2014 funds construction of three new schools on the Agnews campus, expands overcrowded schools, and addresses critical facility needs such as replacing roofs and adding air conditioning to elementary school classrooms. Measure BB 2018 funds the construction of three new schools, reconstructs fields, replaces aging play structures and playground paving, adds shade structures, and upgrades fencing and gates, among many other crucial projects. Age of School Buildings

The main campus of Laurelwood was built in 1963 and 1964 with additions made in 1969 and 1980. Portables were added in 1998 and 2004. This school has 36 classrooms, a multipurpose room, a library, and an administration building. Major classroom and school-wide modernization occurred during the 2005-06 school year and was completed during the summer of 2006.

Fiscal Year 2023-24 Types of Services Funded

Laurelwood Elementary School receives funding from various sources to support student learning and well-being.

These sources include:

- District Funding: This funding covers essential services such as staff salaries, professional development, new teacher training, special education services, facilities, and maintenance.
- Site Funding: This funding provides supplies and materials for students and the facility.
- Targeted Assistance: This funding supports additional staff development, teacher training, and extra support personnel as outlined in the Single Plan for Student Achievement (SPSA). These funds are specifically allocated to provide intervention support for the most at-risk students.

Targeted funds are strategically used to support three main goals:

- STEAM Education: Promoting hands-on learning in science, technology, engineering, art, and math.
- ELA/ELD: Enhancing instruction in English Language Arts and English Language Development.
- Positive School Climate: Fostering a safe, respectful, and supportive learning environment.

To achieve these goals, targeted funds are allocated to various areas, including:

- Small group intervention for struggling learners.
- Teacher release time for collaboration and data discussions.
- STEAM and garden lessons.
- Positive Behavior Intervention System (PBIS) implementation.
- Safety planning and training.
- Professional Learning Community (PLC) release time.
- Special Education Services

Donations help support school activities:

To further enhance STEAM education, the school organizes the annual Laurelwood Walk-a-thon, a fun event that raises funds for STEAM materials and activities. The school's active PTA also plays a crucial role in enriching the student experience. The PTA donates funds assemblies, field trips, and other school-wide enrichment activities. Additionally, parent volunteer groups organize multicultural events, including dances from various cultures, and direct the annual Nutcracker play.

Laurelwood provides comprehensive special education services to students with disabilities through district-funded Individualized Education Programs (IEPs) or 504 plans. These services may include speech and language support, occupational therapy, and specialized reading and math instruction.

Professional Development

Staff development activities and expenditures are tied to district and school goals including the SPSA, WASC, LCAP, and District Strategic Plan. Staff development time continues to support teachers in self-reflection, analysis of student achievement data, and collaboration activities designed to help reach achievement goals. We believe in modeling lifelong learning for our students by engaging in collaborative sessions and professional development opportunities that align with the school's Single Plan for Student Achievement (SPSA) goals and support student achievement in content standards and Expected Schoolwide Learning Results (ESLRs). District and school staff development programs support meeting the academic, social, and emotional needs of all students by providing opportunities for teachers to advance their skills, develop teaching strategies, and create curriculum. During staff in-service days, teachers share information about instructional practices, cognitive development and learning disabilities, and best practices for English Language Learners. These presentations and workshops help us understand who our students are so we can better support them with individual counseling, curriculum design, and instructional practices.

In addition to the number of school days dedicated to districtwide professional development, there is professional development happening on the school campus through professional learning communities, where teachers meet to discuss best practices while assessing student work.
