### 2024-25 School Description and Mission Statement

The mission of Ponderosa Elementary School is to develop a caring community of life-long learners that fosters continual growth. Ponderosa Vision, addresses that we are a diverse and inclusive school community committed to academic excellence. We provide instruction in a respectful, responsible, safe and kind learning environment through collaboration with faculty, families and community.

In the development and improvement of the whole child we address 4 components of our focused plan for academic excellence and the social-emotional health and wellness of our students, families, and staff:

Our SPSA Goals for this year include:

Overall Student Academic Progress:

School Goal: The overall percentage of students who are early on, mid, or above grade level will improve by 20 percentage points in iReady from Diagnostic 1 to Diagnostic 3 in ELA. Our 3-year goal is to see the overall percentage of students early on, mid, or above grade level improve to 67%+.

Supporting our Efforts to Close the Opportunity/ Achievement Gap:

Students identified as EL and/ or Special Education will improve at least one academic performance band as measured in iReady data from Diagnostic 1 to Diagnostic 3. Our 3-year goal is to have less than 10% of students performing 2 or more grade levels below.

Social-Emotional Well-Being and Student/ School Connectedness:

We will reduce the Chronic Absenteeism rate by 3% as measured in the CA State Dashboard. The State Average is ~25%, we are at 15.7%. Our 3-year goal is to get under 9%.

Strengthening Family Connectedness/ Student Enrichment:

We will have 30%+ of families participating in their child's education and with the school community as measured by participating or volunteering in the student's classroom during the instructional day, on a field trip, in an advisory committee meeting, or in an event before, during, or after school on campus (not to include Back to School night or Open House). This will be measured by attendance taken by staff, sign-in sheets, or parent surveys.

And our site priorities to help guides us in achieving these goals are:

Priority #1: Support our Multilingual Learners with ELD

Priority #2: Provide targeted small group instruction for focal students

Priority #3: Engage, connect, and build community with families

Ponderosa Elementary School has a student body of approximately 525 ethnically, socially, and academically diverse students in grades TK-5.

We have a robust special education program on our campus featuring three Specialized Academic Instruction (SAI) classrooms a K/1, a 2/3, and a 4/5th grade offering and 2 RSP teachers supporting as case managers and service providers.

Ponderosa's campus includes 30 classrooms, a library media center, a multi-purpose building, and an administration building that houses the school office, a nurse/first aid station, and teacher work areas. The school facility was modernized in 2004 and again in 2016. New playground equipment was installed on all three playgrounds in 2019. There is a facility for preschool and daycare/ after-school care on site.

Ponderosa was named a California Distinguished School in 1997 and 2004. Ponderosa received the Gold Positive Behavior Intervention Strategies (PBIS) Implementation Award in 2019. Ponderosa Superstars are committed to our PBIS motto: Be respectful; be responsible; be safe, and be kind!

## School Facility Conditions and Planned Improvements

General Santa Clara Unified School District (SCUSD) takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, SCUSD uses a facility survey instrument developed by the State of California OPSC. The results of this survey are available by request made to the SCUSD's Facilities department at (408) 423-2061. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

### Maintenance and Repair

SCUSD maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

### Cleaning Process and Schedule

The governing board has adopted cleaning standards for all schools in SCUSD, Board Policy 3514. The policy can be found online at [www.santaclarausd.org/BoardPolicies](http://www.santaclarausd.org/BoardPolicies). The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

### Deferred Maintenance

SCUSD participates in the State School Deferred Maintenance Program to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

### Modernization Projects

SCUSD strives to be a model of financial responsibility, making every effort to spend taxpayer dollars wisely. At the same time, ongoing bond programs are necessary in a district this large, with so many students, teachers, and facilities needs. Bond funds allow the District to maintain safe, modern school facilities and bring in updated technology essential to student achievement. Measure B 1997 improvements included new elementary school play structures, new high school science classrooms and outdoor athletic facilities, the major renovation of eleven elementary schools, an ambitious roof replacement program, and two high school performing arts buildings.

### Age of School Buildings

The main campus of Ponderosa was built in 1964 with additions made in 1968 and 1977. Portables were added in 1978 for class size reduction. There are 30 classrooms, a multipurpose room, a library, and an administration building.

## Fiscal Year 2023-24 Types of Services Funded

Ponderosa receives targeted allocated funds to support programs that benefit our populations historically underserved, including English Learners (aka Emerging Bilinguals or Multi-linguals), those with low socioeconomic status, and foster/homeless youth. Money is used to fund programs such as Literacy Intervention Teachers (LIT), Intervention Teacher, Small Group Instruction Para Support, and English Learner Support Teacher.

Comprehensive Coordinated Early Intervening Services (CCEIS) money is used to fund a CCEIS Coach in order to address the over-representation (based on averages) of minority students, specifically Hispanic and Latino males, identified with a learning disability. The CCEIS Coach works with kindergarten through fifth-grade teachers on strategies to differentiate instruction and to support struggling students. This year, we focus on oral language development in students across all subject areas and utilizing instructional strategies to promote more student collaboration and shared talk time.

Ponderosa is fortunate to have a very active PTSA and a parent led foundation group. Ponderosa Enrichment Programs Committee (PEPCO) is a non-profit organization founded to build a stable funding source to support additional staff resources and supplemental programs. PEPCO primarily raises funds through direct donations, participation in ongoing passive fundraising programs (e.g. eScrip and Box Tops), and through special fundraising events (e.g. Catalog Sales, Walk-a-Thon). Funds are used to support such endeavors as a recess enrichment program, a fine arts program, and a performing arts program.

## Professional Development

Staff development activities and expenditures are tied to district and school goals including the SPSA, WASC, LCAP, and District Strategic Plan. Staff development time continues to support teachers in self-reflection, analysis of student achievement data, and collaboration activities designed to help reach achievement goals. We believe in modeling lifelong learning for our students by engaging in collaborative sessions and professional development opportunities that align with the school's Single Plan for Student Achievement (SPSA) goals and support student achievement in content standards and Expected Schoolwide Learning Results (ESLRs). District and school staff development programs support meeting the academic, social, and emotional needs of all students by providing opportunities for teachers to advance their skills, develop teaching strategies, and create curriculum. During staff in-service days, teachers share information about instructional practices, cognitive development and learning disabilities, and best practices for English Language Learners. These presentations and workshops help us understand who our students are so we can better support them with individual counseling, curriculum design, and instructional practices.

In addition to the number of school days dedicated to districtwide professional development, there is professional development happening on the school campus through professional learning communities, where teachers meet to discuss best practices while assessing student work.
