Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2024-25 School Description and Mission Statement

Scott Lane Elementary School's mission is to ensure the success of every scholar by fostering a supportive, inclusive, and academically enriching environment.

Scott Lane Elementary School has proudly served the Santa Clara community since 1953. Established to accommodate families moving into the post-World War II housing boom in the Santa Clara Valley, the school is strategically located near the Santa Clara City Hall, at the heart of a vibrant residential area.

2024-25 School Description and Mission Statement

Today, Scott Lane is one of twenty elementary schools in the Santa Clara Unified School District, serving 416 students from diverse backgrounds. With over 18 languages spoken by students and their families, the school reflects the multicultural fabric of its community. Of the student population, 49.04% are Immersion Bilingual Learners, and 62.98% participate in the Free/Reduced Lunch program. Additionally, the school experiences a mobility rate exceeding 25%, with many students coming from single-parent households or homes where both parents work.

Academic Excellence and Innovation

Scott Lane combines the talents of its students, staff, parents, and community to exemplify high-quality education. A cornerstone of this innovation is the Spanish Dual Language Immersion (DLI) Program, launched in 2020, which aims to cultivate bilingualism and biliteracy. The program integrates native English speakers and native Spanish speakers to foster academic achievement and cross-cultural understanding, equipping students with essential skills for a globalized world.

The school is also a proud implementer of an academic language model, which emphasizes enriched language and literacy education for immersion bilingual learners. This comprehensive approach builds academic success and social-emotional growth from preschool through fifth grade, bridging research, practice, and policy to create long-term systemic impact.

A Commitment to Student Success

At Scott Lane, staff collaboration and professional growth are central to ensuring every student thrives. Teachers are highly trained in research-based instructional strategies and continuously work together to analyze student work, refine teaching practices, and design targeted interventions. Through the school's robust intervention model, all students receive small-group, personalized instruction tailored to their unique needs.

In addition, the school supports student well-being with a 40% PIP counselor, intervention paraeducators, and the Busy Getting Stronger (BGS) Program. Instructional assistants provide academic and language support for students and families alike. Classified staff are well-versed in literacy development, academic language techniques, and strategies for working with bilingual learners, ensuring a cohesive and effective learning environment.

A Vision for the Future

Scott Lane Elementary School envisions students as confident, capable individuals prepared for the challenges of tomorrow. The school strives to develop students who excel as readers, writers, thinkers, and communicators while embodying respect, responsibility, resilience, and problem-solving skills. School Facility Conditions and Planned Improvements

General

Santa Clara Unified School District (SCUSD) takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, SCUSD uses a facility survey instrument developed by the State of California OPSC. The results of this survey are available by request made to the SCUSD's Facilities department at (408) 423-2061.

Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Maintenance and Repair

SCUSD maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule

The governing board has adopted cleaning standards for all schools in SCUSD, Board Policy 3514. The policy can be found online at www.santaclarausd.org/BoardPolicies. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance

SCUSD participates in the State School Deferred Maintenance Program to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

Modernization Projects

SCUSD strives to be a model of financial responsibility, making every effort to spend taxpayer dollars wisely. At the same time, ongoing bond programs are necessary in a district this large, with so many students, teachers, and facilities needs. Bond funds allow the District to maintain safe, modern school facilities and bring in updated technology essential to student achievement. Measure B 1997 improvements included new elementary school play structures, new high school science classrooms and outdoor athletic facilities, the major renovation of eleven elementary schools, an ambitious roof replacement program, and two high school performing arts buildings. Measure J 2004 generated funds to modernize buildings and classrooms for middle schools, high schools, and the adult education campus. Measure H 2010 upgraded fire, safety and security systems, renovated and reopened a closed elementary school, installed solar panels to decrease energy costs, purchased the Agnews campus property, and expanded overcrowded schools. Measure H 2014 funds construction of three new schools on the Agnews campus, expands overcrowded schools, and addresses critical facility needs such as replacing roofs and adding air conditioning to elementary school classrooms. Measure BB 2018 funds the construction of three new schools, reconstructs fields, replaces aging play structures and playground paving, adds shade structures, and upgrades fencing and gates, among many other crucial projects.
