The Opportunity Scholarship Tax Credit Program was created pursuant to Act 85 of 2012 (72 P.S. § 1701-G.1, et seq) and amended by Act 86 of 2016 (24 P.S. § 2001-B, et seq). This program enables eligible students, residing within the boundaries of low-achieving schools, to apply for a scholarship to attend a participating public or nonpublic school.

Low-achieving schools are defined as public elementary and secondary schools (excluding brick-and-mortar and cyber charter schools, and area vocational-technical schools) within the Commonwealth that ranked in the lowest 15 percent of its designation (elementary or secondary) for the school year, based on the combined Mathematics/Algebra I and Reading/Literature scores from the most recent annual assessments (PASA, PSSA, and/or Keystone) administered.

The Pennsylvania Department of Education (PDE) posts the list of low-achieving schools annually so that eligible students can apply for scholarships for the upcoming school year. Students who reside in an attendance zone of a school that was on a previous list of low performing schools but is not on the 2023-2024 school year list may also apply to a scholarship organization to continue receiving a scholarship.

## Overview of the Opportunity Scholarship Tax Credit Program

**Establishment:** The Opportunity Scholarship Tax Credit Program provides scholarships to eligible students who wish to attend a participating public or nonpublic school of their choice.

Eligibility: The Opportunity Scholarship Tax Credit Program allows businesses to contribute to an opportunity scholarship organization that provides funding to eligible students who reside within the attendance boundaries of a low-achieving school. A low-achieving school is defined as a public elementary or secondary school in Pennsylvania that ranks in the bottom 15 percent of its designation as an elementary or secondary school based on combined Mathematics/Algebra 1 and Reading/Literature scores on the most recent annual assessment (PSSA, and/or Keystone). This term does not include a brick-and-mortar charter school, cyber charter school or area vocational-technical school. Students (including students entering kindergarten) who reside within the boundaries of a low-achieving school as of the first day of classes will be eligible to apply for an opportunity scholarship. Eligible students may include children residing within the boundaries of a low-achieving school who:

- Currently attend a low-achieving school;
- · Are currently enrolled in a non-public school;
- · Were previously home schooled; or
- · Were previously attending a charter or cyber charter.

Eligible students are defined as those school-age children living in the attendance boundary of a low-achieving school as of the first day of classes. The income information and information on additional allowances for people with disabilities can be found on the Department of Community Economic Development's (DCED) website at:

Opportunity Scholarship Tax Credit Program (OSTC) - PA Department of Community & Economic Development

The Pennsylvania Department of Education (PDE) will annually publish a list of the bottom 15 percent of elementary schools and the bottom 15 percent of secondary schools.

**Continuation of Scholarship**: A scholarship organization may award a scholarship to an applicant who resides within the attendance boundary of a low-achieving school to attend a participating public school or a participating nonpublic school selected by the parent of the applicant. If an applicant who received an opportunity scholarship

for the prior school year resides within the attendance boundary of a school that was removed from the list of low-achieving schools provided by the department, the applicant may receive an educational opportunity scholarship. The scholarship may be for each year of enrollment in a participating public school or participating nonpublic school for up to the lesser of five years or until completion of grade 12 provided the applicant otherwise remains eligible.

Funding: Opportunity scholarships are funded by businesses making contributions to scholarship organizations in exchange for a tax credit. The amount of scholarships cannot exceed the amount of business contributions made to scholarship organizations. Even if a student is eligible for a scholarship, that scholarship is contingent upon funds being available.

Requirements: The scholarship can only be used for tuition costs and school-related fees at the participating nonpublic school or nonresident public school district. A scholarship shall not be awarded for enrollment in a home education program. The combined amount of scholarship and additional financial aid may not exceed the tuition rate and school-related fees associated with the participating school. Scholarship funds received by a parent are not considered taxable income. A participating public or nonpublic school may not charge a higher tuition rate than its normal rates for nonparticipating students.

**Transportation:** A resident school district that provides transportation to its own students must provide transportation for a resident student attending a participating nonpublic school that is located within 10 miles of the resident school district's boundaries. A resident school district that provides transportation to its own students may provide transportation for a resident student attending a nonresident public school that is located within 10 miles of the resident school district's boundaries.

How to Apply for an Opportunity Scholarship: Opportunity scholarships will be awarded by approved opportunity scholarship organizations, not the Pennsylvania Department of Community and Economic Development (DCED) nor PDE. The list of opportunity scholarship organizations is available on DCED's website at:

Opportunity Scholarship Tax Credit Program (OSTC) - PA Department of Community & Economic Development

This link provides specific instructions on how to contact approved opportunity scholarship organizations. Approved opportunity scholarship organizations will provide details regarding their application process. Parents should work through the approved opportunity scholarship organizations, not DCED, to participate in this program.

Awarding of Scholarships: In awarding an opportunity scholarship, a scholarship organization shall give preference to eligible applicants who:

- Received a scholarship for the prior school year;
- · Who meet certain income limits; or
- Who meet certain income limits and who reside in a first class school district, a district with an average daily membership greater than 7,500 that has received an advance of its basic education subsidy, or a district that has received an advance of its basic education subsidy and is either subject to a declaration of financial distress under section 691 of the Public School Code or is engaged in litigation against the commonwealth in which the school district seeks financial assistance from the commonwealth to allow the school district to continue to operate.

Parental Responsibilities: Under the program, parents are responsible for contacting and enrolling their students in a participating public or nonpublic school.

Dear Parent or Guardian,

The Scranton School District believes that student learning needs are well supported in neighborhood schools. Board approved **Policy 206-<u>"ASSIGNMENT WITHIN DISTRICT"</u>** states that all students must attend their school within its boundary residence zone.

Under certain circumstances, however, the defined school boundaries may not always meet the needs of students and/or families. The Board provides parents with an alternative under the Scranton School District Boundary Exception (BEX) Policy.

Permission to attend a school outside of the mandated attendance area is granted on an annual basis and is dependent upon available space in the grade level requested. The availability of space will be determined by the building principal in conjunction with the Assistant Superintendent of the Scranton School District-Mr. Albert P. O'Donnell. Boundary Exceptions will be granted for a term of one year. Parents must complete a new boundary exception request form each year for renewal purposes. The deadline for the submission for the 2025-26 school year is May 15, 2025. The Scranton School District does not provide transportation for students attending a school on a boundary exception.

Please be advised that boundary exceptions that have been granted will be rescinded if the classroom roster exceeds the contractual class size limit at any time throughout the duration of the school year or if a student becomes disruptive and/or if truancy issues arise. Boundary exceptions will be rescinded based on a last in, first out basis.

Please complete the attached form requesting the boundary exception and return it to the Scranton School District administration building at 425 North Washington Avenue. <u>Original signatures are required and faxed copies will not be accepted.</u> Boundaries are based on a yearly basis only.

- 6. There will be no exceptions made to this procedure. The parent or guardian's signature on the Application for a Boundary Exception indicates that the parent understands this policy and that they understand that their child's Boundary Exception can be revoked at any time if the classroom exceeds the contractual class size limit.
- 7. Boundary Exceptions will be granted for a term of one year. Parents must complete a new (renewal) boundary exception request form each year and submit it by May 15 of the previous year.
- 8. When a student from either South Scranton Intermediate School(from Whittier boundary) or Northeast Intermediate School applies for a BEX to go to West Scranton High School at the end of 8<sup>th</sup> grade (due to extenuating circumstances), if approved, that decision is final and the student must remain at West Scranton High School for the entire four years.
- 9. When a student from either West Scranton Intermediate School or South Scranton Intermediate (Plaza/JFK Boundary) School applies for a BEX to go to Scranton High School at the end of 8<sup>th</sup> grade (due to extenuating circumstances), if approved, that decision is final and the student must remain at Scranton High School for the entire four years.
- 10. Between May 15 and June 1 of each school year, principals may submit a list to their respective Supervisors of those students whom they wish to have Boundary Exceptions revoked for the next school year. The reasons for revocation must be well documented. Once a decision is made, the building principal will send a letter to the parent explaining why the boundary exception is being revoked. This letter will also provide the parent with the information regarding their home school.
- 11. Reasons BEX are approved:
  - a. Due to extenuating circumstances (including but not limited to: hardship, PFA's, abuse, foster placement, court orders, family strife etc.). Superintendent approval required!
  - b. Professional Courtesy (The SSD employee must be employed in the building of request).
  - c. Overage situation at a particular school. In this case the student will attend the next closest neighboring school with transportation provided.
  - d. Occupational Scholarship Tax Credit Program (OSTCP) if the home school qualifies.

### TRANSITION OF STUDENTS WHO APPLY FOR A BEX. DURING THE COURSE OF THE SCHOOL YEAR

1. If a student transfers out of the boundary of their home school during the course of the school year (after quarter 3) they must attend the school of residence unless the principal approves the student to finish the school year in their BEX building.

#### POLICY FOR BOUNDARY EXCEPTIONS (BEX) FOR THE 2025-26 SCHOOL YEAR

The Scranton School District believes that student learning needs are well supported in neighborhood schools. Policy 206-"ASSIGNMENT WITHIN DISTRICT" requires all students to attend the school within their living boundary. Under certain limited circumstances, however, the defined school boundaries may not always meet the needs of students and/or families. The Board will provide an alternative under the Boundary Exception Policy to the extent that its financial resources, accommodations, and contractual obligations permit. Under the Boundary Exception policy, students may apply due to extenuating circumstances to attend schools other than their home school. The Superintendent will need to approve this request.

### APPLICATION FOR ADMISSION TO SCHOOL OTHER THAN HOME SCHOOL

- 1. Application to attend requested school shall be made by May 15 for the upcoming school year (Ex: May 15, 2025 for 2025-26 SY).
- 2. Application shall be made on the appropriate form (English or Spanish) and shall be signed by the parent or legal guardian. Please include a copy of a photo ID.
- 3. All applications must be returned to:

4. The signature of the Assistant Superintendent when applicable will acknowledge awareness of the application and will confirm the status of the application (approved or denied).

### **ADMISSION**

- 1. Selection for admission to a school will be based on the availability of space and a consultation between the building principal and his/her respective supervisor.
- 2. A principal may refuse admission to a student if he/she believes such admission would not be in the best interest of the student and/or school.
- 3. In the event of the approval of an application, the students will be admitted to the requested school.
- 4. BOUNDARY EXCEPTIONS THAT HAVE BEEN GRANTED WILL BE RESCINDED IF THE CLASSROOM ROSTER EXCEEDS THE CONTRACTUAL CLASS SIZE LIMIT AT ANY TIME THROUGHOUT THE DURATION OF THE SCHOOL YEAR. This will be considered an "OVERAGE" situation.
- 5. Boundary exceptions will be rescinded based on a last in, first out basis. In other words, the student whose boundary exception application was approved last will be the first student to have his/her boundary exception rescinded and will be required to return to their home school.
