The Carlisle Public School's Lunch Program is committed to the mission of serving all children a nutritious, well-prepared meal in a safe and friendly environment, and we welcome and encourage the participation of your child/children.

Lunch prices will be free and second lunch will be charged according to what was purchased. All meals include an entrée choice with options of a vegetable, fruit and milk. Each child must take three out of the five components and one of the three must be a fruit or vegetable.

Parents are encouraged to take advantage of our easy and secure online pre-payment service. To deposit money into your child's meal account, please visit [www.mymealtime.com](http://www.mymealtime.com). From this site, you will create your account and add money to your child's school meal account. If you choose not to take advantage of the online pre-payment service, you may continue to make advance payments by check, which should be made payable to "Town of Carlisle" or you may pay with cash.

After eating lunch, children have the opportunity to purchase a Smart A-List La Carte Snack. Students are never allowed to purchase snacks on their account just beverages, they must use cash for all snacks. All snacks are A-list approved by the John Stalker Institute and meet the Massachusetts schools competitive food and beverage standards. All nutritional information is available upon request.
