2024-25 School Description and Mission Statement

Nile Garden School is TK-8 campus of approximately 1,150 students located on the outskirts of Manteca’s city limits and rural Manteca. We are a combination of busing as well as parental drop off for students. Our original school buildings were built in 1963. Starting in 2019, Nile Garden was the recipient of a multi-million-dollar renovation funded by Measure G which included a new Classroom Building with a new Kindergarten suite, playground structures, additional portables, multipurpose room and learning commons. In addition to the new classrooms, we have a new Administration office, increased parking to our front parking lot, and east parking lot which was to be designated for staff parking and bus drop off. We are currently under a Phase 2 of the remodel that began November 2024 with a completion date of August 2026. This phase of remodel will include two

permanent buildings with eight classrooms each, one interior learning commons and one exterior learning commons and two sets of restrooms. With them being completed, the existing portables on the west side of campus will be removed. Historically, Nile Garden is recognized within the district for its consistently high academic standards and student performance with a California Distinguished Schools award recognition in 2020. We provide our students with the best available interventions at our disposal including Edmentum's Exact Path, Give Every Child A Chance one-to-one tutoring, Mine Craft for Education, Rosetta Stone and designated access time to target student learning deficits. The Give Every Child a Chance/ASAP program hosts an after school three-hour program that provides on average 120 (attendance to increase in January pending hiring of staff) students daily with homework support, physical activity, and enrichment at no cost to our families. Through the Expanded Learning Opportunities Program GECAC provides extended learning opportunities during MUSD's long breaks (Fall Break, Winter Break, Spring Break). Staff has also signed up to provide a variety of Expanded Learning Opportunities from sticker making, to a chess club to cooking classes.

Strong parental support and involvement through parent volunteers as well as our Nile Garden Community Club, compliments our well-trained staff of professionals. We also have a Strategic Plan that highlights the focuses for each district target area: Grade Level Standards, Safety, and Emerging Students.

Additionally, we have a full-time counselor at our site. In support of the students of families in the Transitional Student Support Program we have provided a Community Liaison to assist them with accessing various helpful resources. To create a strong relationship between parents, students and teachers, a Community Liaison is on staff for 3 hours per day to work to remove barriers to educational success for our students.

School Facility Conditions and Planned Improvements

The District takes great effort to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses the Facility Inspection Tool (FIT) instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the District Office. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Age of School Buildings

Nile Garden School was built in 1963 including the administration building, library, multi-purpose room, and classrooms. Several classrooms have been added for a total of 46 classrooms. In 2005, the library and classrooms were remodeled. (2) Portable classrooms were added in 2023.

Maintenance and Repair

District maintenance staff ensures that repairs necessary to keep schools in good working order are completed in a timely manner. A work order process is used to ensure efficient service and emergency repairs are given the highest priority.

Cleaning Process and Schedule

The District's governing Board has adopted cleaning standards for all schools in the District. A summary of these standards is available at the school office and at the District Office. Staff works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Maintenance Program

The District allocates funding for maintenance. The Maintenance Program includes funding for replacement of existing school building components so that the educational process may safely continue. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, wall systems, floor systems, etc.

Modernization Projects

The District is currently planning to renovate and modernize its schools based upon the District's 2014 Facility Master plan and 2019 Needs Assessment. As part of that activity there are projects planned at Nile Garden which will be completed through the use of local funds. State funding will also be sought for those portions of projects which may be eligible for modernization funding. The modernization of Nile Garden School was completed in 2022. The modernization includes the construction of a new multipurpose room, kindergarten classrooms site work and accessibility upgrades, phase 2 started construction in 2024 and include (2) B classroom buildings to replace aging relocatable classroom buildings.

Education meeting, current school safety plans were unanimously approved by the MUSD Board of Education.

The safety of students and staff as well as the security of school campuses are high priorities in MUSD. Safety plans in place are thorough and inclusive of various forms of threats and the protocols aligned for each situation. Staff and students receive ongoing training throughout the school year on emergency response and participate in regular disaster preparedness drills including but not limited to specific procedures for fire, earthquake, flood, civil disturbance, and hazardous chemical situations as aligned with state guidance. Safety plans evolve as necessary to adapt to current local, state, and national conditions.

Each school in Manteca Unified has a dedicated site safety team made up of key personnel who represent differing areas of expertise and perspective relating to campus logistics. The team meets regularly to review, adjust, and implement the best safety procedures for their school communities. Plans outline the many components necessary for a comprehensive safety plan such as steps for preparedness, proactive measures for prevention, emergency response, and a thoughtful blueprint for recovery.

As Manteca Unified School District attendance boundaries expand beyond city limits, MUSD partners and works closely with six law enforcement agencies, three fire departments, and many local first responders. MUSD's master emergency plan as well as school safety plans are reviewed by these agencies.

Site safety team members are requested to earn their ICS 100 certification upon joining the team. Several members of District senior leadership, site principals, and MUSD's Coordinator of Emergency Preparedness and Safety maintain an ICS 402 certification.
