## 2024-25 School Description and Mission Statement

This farm, adjacent to the playground, includes farm animals (sheep, goats, chickens, ducks, geese, pigs, turkeys, and turtles). Golden View also has a garden that is shared by all classrooms with over 800 square feet of community space. This unique facility provides students with exceptional opportunities for hands-on learning, caring for animals, planting seeds according to seasons, observing, maintaining, and cooking with the harvest. Students and teachers utilize the farm to integrate environmental learning across all curricular areas while promoting social skills. Students have opportunities for after-school nature programs, as well as participation in composting and recycling programs across the grade levels. The Farm is a beloved part of our students' elementary school experience and families are encouraged to get involved.

Golden View Elementary School is located in the western region of Huntington Beach and serves students in grades Transitional Kindergarten through five following a traditional calendar. The Ocean View School District is located in western Orange County and serves over 7,000 students from prekindergarten through eighth grade. ## School Facility Conditions and Planned Improvements

In November of 2016, the Ocean View School District (OVSD) passed Measure R, a general obligation bond, in the amount of 169 million dollars. This is the first bond ever passed in the 143 year history of OVSD. The bond program is designed to transform the aging fleet of 1960/1970 era schools into modern, contemporary learning environments. Construction started in June of 2018 and anticipate completion in the 2024 school year.

## School Facility Conditions and Planned Improvements

The District uses a systematic approach to maintain facilities to ensure all schools are clean, safe, and provide an inspirational educational environment for our students to learn, grow, and be challenged. District maintenance and site custodial staff work in a coordinated manner to ensure that the repairs and operational items necessary to keep the schools in good condition are completed in a timely manner. A comprehensive work order system is used by school and District staff to communicate both routine and non-routine maintenance requests. Emergency repairs are given the highest priority.

From an operational perspective, the custodian inspects the facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One full-time day custodian and one or two part-time evening custodian(s) are assigned to each school site. The day custodian is responsible for:

- Lunch area
- General grounds maintenance
- Grounds keeping
- Restroom cleaning

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodian is responsible for:

- Classroom cleaning
- Office area cleaning
- Restroom cleaning

The principals are in continual communication with the Maintenance and Operations Supervisors and custodial staff concerning maintenance and school safety issues.

## Professional Development

Non-student days are built into the calendar and only represent opportunities that ALL teachers participate in throughout the year. The focus for the 2024-25 school year is Universal Design for Learning (UDL), family engagement, writing across the curriculum, Momentum in Teaching Narrative and Informational writing, English Language Development (ELD), phonics/decoding/morphology, small-group differentiated instruction, i-Ready personalized pathways, Multi-Tiered Systems of Supports (MTSS) for academics, and more.

Elementary sites have modified Wednesdays. Students are released early to allow time for teachers to focus on professional learning, collaboration, and planning. Two Wednesdays a month are devoted to professional learning and collaboration as led by administration, and the other two Wednesdays are dedicated to teacher collaboration and teacher planning. Other professional learning opportunities are made available for teachers who are representing their school and bringing back information and professional learning provided for school site administrators to bring back and share with staff.
