1st Grade:

1.2 D (D) blend spoken phonemes to form one- and two-syllable words, including consonant blends (e.g., spr)

Students will increase from 18% to a 70% developed for the 2024-2025 school year.

2nd Grade:

2.4a the student is expected to use appropriate fluency when reading grade level text.

The percentage of students reading 90 wcpm or higher will increase 15 % to 60% for the 2024-2025 school year.

3rd Grade:

3.4 A Developing and sustaining foundational language skills: listening, speaking, reading, writing, and thinking --fluency. The student reads grade-level text with fluency and comprehension. The student is expected to use appropriate fluency (rate, accuracy, and prosody) when reading grade-level text.

By May 2023, 70% of 3rd grade students will achieve a reading fluency rate to 120 wpm.
