- **Physical Education/Health – Bill Allen**
 - How to implement PE and Health TEKS in Elementary and Middle, character lessons, Game Day
 - 18 weeks long with word of the week
 - Fitness Gram coming in April
- **Sexual Health and Wellness – Lori Roque**
 - All 4th graders received instruction
 - Parents could opt out
 - Only 10% did
 - 5th grade instruction coming
 - 6-12 grade instruction will happen in May after STAAR testing
- **Nurse – Christi Gregory**
 - Implemented stock epinephrine at all campuses last year (2023-2024)
 - Shot clinic coming up in April through the Health Department
 - 6th graders will be offered shots for 7th grade school year in April
 - CHS students in May
- **Nutrition – Stefanie McBroom**
 - Ice storm caused deliveries to be delayed
- **Safety and Security – Rickie Leck**
 - District vulnerability assessment in October
 - Rubric sent – CISD faired very well
 - Findings were minor except the counterclockwise numbering of the doors at CHS
 - Silent panic button device rolled out before Christmas
 - Substitutes being trained as they are hired
- **Mental Health – Glenna Pollock**
 - Monique Burr curriculum implemented at CHS in December 2024
 - Board approved adding curriculum at Smith
 - Smith and Wheat will receive instruction in May 2025
 - Parents must opt-in according to Senate Bill
