Scholarship Policies and Procedures

Pursuant to the authority granted to the Advisory Board by the Trustee, the following policies and procedures have been established by the Advisory Board.

To the extend funds are available, scholarship awards are made to full-time students enrolled in colleges or universities of their choice as long as the program of the school selected meets the particular need of the student receiving the scholarship. To be eligible for a scholarship, a student must be a graduate of a high school in Galveston, Texas. Scholarship awards are made solely for the purpose of assisting students to complete their undergraduate college or university work, including but not limited to such expenses as tuition, room, board, fees and other expenses directly related to their education and maintenance while in undergraduate work. The basic criteria for a scholarship from the Fund includes, but is not limited to, academic ability, extra curricular activities and financial need of the applicant. Applicant must be in the upper 25% of his class.

Applicants will be required to submit a photo, certified copy of H.S./ College Transcripts & Grades, statement on why you want/deserve the scholarship (250 word limit), and a letter of recommendation from the student's high school counselor or a high school teacher.

Students who have completed two (2) semesters of undergraduate college or university work will be eligible for renewal awards as funds are available. Student will be required to submit a copy of the college transcript evidencing work completed through the date of the application. If in College, a letter of recommendation from a person other than a relative and a grade point average of 2.50 on a four point scale will be required.

The Advisory Board and the Trustee will meet at least annually, during April, to consider the applications submitted for the school year beginning with the following September. Applicants who wish to be considered must have their applications and other pertinent data in the hands of the Trustee by March 31st each year.


Application forms and explanations of policies and procedures may be obtained from counselors and/or principals of the high schools located in Galveston, Texas or from the Trustee bank.

Students who discontinue their college or university work will be required to immediately notify the Trustee.

The Advisory Board reserves the right from time to time to revise or amend the statement of policy except that no such revision or amendment shall affect the scholarship grants in existence at that time.

The Peter Andrew Sunseri Memorial Scholarship Fund was established by an Indenture of Trust by Carroll G. Sunseri and Andrea P. Sunseri in memory of their son, Peter Andrew Sunseri, 16, who died in an automobile accident on April 25, 1986. Peter was born in Galveston, Texas on January 10, 1970 and was a tenth grade student at Ball High School in Galveston at the time of his death. He was a member of the National Honor Society and the tennis team. The United States National Bank of Galveston, Texas, now Frost Bank, was appointed Trustee and an Advisory Board was established to administer the awarding of scholarship grants to deserving high school graduates of Galveston, Texas pursuant to the policies and procedures of the Advisory Board.

Mr. Peter M. Moore is Chairman of the Advisory Board; other members include Peter's mother, Andrea P. Sunseri, sisters, Carolyn L. Sunseri and Stephanie S. Doyle, nieces Allie D. Ryan and Shannon D. Osborn: Harris L. Kempner, Jr. and Peter E. Scofielia.

Grants will be made to the college or university of the recipient's choice and not directly to the individual.
