I further swear that the foregoing statements included in my application are in all things true and correct."

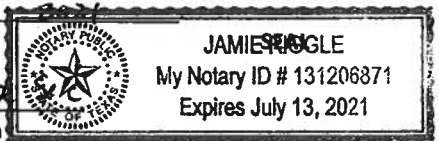

The Texas Ethics Commission has received your campaign treasurer amendment. Please use your Filer ID number on all correspondence and documents that you submit to the Commission.

Forms, Schedules, and Guides: Forms, filing schedules, and guides are available on the Ethics Commission's website at <https://www.ethics.state.tx.us>.

Candidate, Not Campaign Treasurer, Must File Reports: As a candidate, you are responsible for filing reports.

Reporting Requirements: You must file semiannual reports with the Ethics Commission not later than January 15 and July 15 of each year. *These reports must be filed even if there was no activity during the reporting period.* Other reports are required in connection with elections. You may also be required to file an annual personal financial statement.

Late-Filing Penalties: The late-filing penalty for most reports is \$500. For a report due eight days before an election and for the first semiannual report required to be filed after a primary election or after a general election, the late-filing penalty is \$500 for the first day the report is late and \$100 for each day thereafter that the report is late.

NOTE: Reports will be required until a campaign finance report designated as a "Final Report" and your Designation of Final Report affidavit are filed.

Electronic Filing Requirement: A candidate who files with the Ethics Commission is required to file campaign finance reports electronically unless the candidate is eligible for the statutory exemption from the requirement to file electronically.

6. Form CFCP (Code of Fair Campaign Practices): *You may file this form to declare your intention to voluntarily comply with the Code of Fair Campaign Practices.*
7. Personal Financial Statement and Instructions. *If you become a candidate on the ballot or an officeholder, you will be required to file a personal financial statement (Form PFS). State law requires the PFS to be filed electronically. To file electronically, you must first complete and return to us the FORM SECURITY-PFS. It will provide us with an email address to which we will send you a link to obtain a password.
