Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. The school is affiliated with the Moorpark Unified School District and housed on the Moorpark College campus. Students from over 25 different public and private schools across Southern California come together to create a dynamic learning environment centered around our core values of Interest, Intellect, Initiative, and Integrity. Students take courses at the high school level and simultaneously earn dual enrollment credit for course work they take at the college level.

HSMC offers a thematic and integrated approach to learning where students learn meaningful content and also develop skills

School Facility Conditions and Planned Improvements

The High School at Moorpark College occupies six portable classrooms located on the 'T' trailer lot, near parking lot G1, on the campus of Moorpark College, and utilizes a storage shed, and patio area shaded with trees, tables and benches. Five of the portables are used as classrooms, and one is used for the office. The classrooms and office are close together, allowing for supervision and student safety, as well as establishing a Learning Community environment. Restrooms are located next to classroom TR-5. Parking is located in front of the classrooms for easy access. Classrooms contain filing cabinets, locked cabinets, a whiteboard, computers, and desks for teachers and students to use. Each room also contains a Newline Board and document camera. The rooms were wired for Internet usage during the 2012-13 school year by the MUSD Technology Department. All students are issued a district-owned Chromebook, making HSMC a 1-1 technology campus. All rooms are cleaned nightly, with maintenance provided by Moorpark College. All Moorpark College facilities are available for use by The High School at Moorpark College students. College courses taken by the students are located on the main college campus. Students have complete access to the Open Access Computer Lab, the Library, and the Campus Resource Center. Students who are taking photography, and other media arts classes, have access to the photo labs, graphics labs, and radio and/or television studio. Moorpark College also provides a Health Services Center that is available to The High School at Moorpark College students. Once parents have signed the proper release forms, students may be seen for any number of medical reasons by medical assistants and registered nurses. Psychological services are also available with parent permission.

2023-24 Career Technical Education Programs

Junior Advisory includes both Self-Paced Career Assessment and Self-Paced Career Research. Through the use of the Naviance computer assessment program, students build awareness of their individual values, interests, skills, and personality attributes as they relate to the world of work. The assessments and research assist students in evaluating and prioritizing college and career options.

Senior Project is a yearlong career research project in which students research a career of interest. Students are encouraged to interview people in the field, complete at least one job shadow and/or internship, and present their findings to their class. They learn the process of investigation and develop keen insights into their chosen careers. In addition, "Mock interviews" are held during the spring of each year. Seniors are required to complete a cover letter, a resume, and to prepare for the "Mock Interview" with an employer in their selected career. Employers such as Archaeologists, Artists, Car Designers, Doctors, Teachers, Attorneys, Business Owners, Actors, Accountants, and Psychologists volunteer to interview students, complete a "hiring rubric," and give viable feedback. Seniors also use the Naviance computer assessment program to evaluate and prioritize career options. Each year the Juniors and Seniors attend the Moorpark College Career Speakers conference. Students are invited to learn about career trends, education requirements and interact with guest speakers.

11th and 12th-grade students have access to Moorpark College CTE courses and can work towards certifications in a variety of

2024-25 Opportunities for Parental Involvement

The Parent Support Organization for The High School at Moorpark College is the Parent, Student, and Staff Association (PSSA). PSSA members participate by giving input and feedback to school administration regarding yearly SPSA goals and completing LCAP surveys launched by MUSD and the Parent Vision survey administered by HSMC. The PSSA also assists with general school-wide events and activities such as our yearly talent show, prom, graduation, winter dance, and other social activities. Leadership positions are available to coordinate fundraising activities, plan and organize student events, prepare educators' appreciation week, chaperone field trips, give tours, offer internships, and assist students with job shadow opportunities. Parents are also encouraged to attend the Principal's Chats that are held every month. Principal's Chats are informal meetings that offer parents the opportunity to get to know the Principal, learn about the happenings at the school, convey concerns, provide viable solutions to issues, offer feedback, and network with other HSMC parents. The overall goals of PSSA are to help improve the instruction and culture of our school community.

The Safe School Plan blends Moorpark College's SEMS plan as well as the Moorpark Unified School District's Emergency Management Plan and the Moorpark College Safety Plan. HSMC communicates by radio during the MUSD District-wide evacuation drill each year. First aid and emergency supplies have been purchased and are stored in the high school's office

and classrooms. The office is located near the Campus Police Department, which is in close communication at all times in the event of an emergency. The Moorpark College Police Department is the law enforcement agency with jurisdiction over all incidents at Moorpark College. In the event of a lockdown situation, the staff communicates by cell phone between the office and classrooms and classroom to classroom. The Campus Police and Dispatch will be summoned immediately by cell phone.

HSMC conducts monthly emergency drills including fire, lockdown, and earthquake preparedness. A debrief is held after each drill to evaluate any necessary changes to assure student safety. An annual school safety plan is constructed and reviewed with staff members and parents each November to ensure HSMC is a clean and safe campus at all times.
