### Consequences

- Limitations to Added Services: Buses may not be available for new students or students with special circumstances
- Overcrowded Buses: Buses may become overcrowded, leading to safety concerns
- Parental Challenges: Parents may need to adjust their schedules to transport their children to and from school
- Increased Costs: School districts may incur higher costs due to the need for alternative transportation solutions

#### Vans


 Beginning in 2024-25, the District has contracted with 3 bus companies to provide van services

# Planning

- Planning for the next school year starts in February and continues through the first day of school:
  - Process non-public school transportation requests
  - Review and update database for public school students, including students with special needs
  - Obtain information and calendars from nonpublic schools
  - Develop bus routes
  - Bid new transportation routes
  - Assign routes to bus companies



## Communication

- Dispatcher on call 12 hours a day from 7:00 AM – 7:00 PM (4:00 PM Friday)
- Text Alerts
- GPS Tracking
  - Provides helpful information to appropriately address issues, such as delays



# Safety is Our Top Priority

- -Camera Installation on Buses and Vans
  - -Monitors the behavior of students, drivers, & matrons
  - -Allows the District to effectively address a range of issues that may arise throughout a trip
- -Driver Screenings
  - -We require thorough background checks and ensure compliance with all NYS regulations throughout the course of the year
- -GPS Tracking
  - -Provides important information regarding the speed and location of vehicles at all times

### Town of Hempstead Bus Stop-Arm Program

- Stop-arm cameras identify illegal passers. Tickets are issued to the vehicle's owner.
- In the program's first year, the town generated \$13M in revenue from over 140,000 fines.



# Additional Services





### Services for Displaced Families

- The McKinney-Vento Homeless Assistance Act
  - Designed to support children and youth experiencing homelessness
  - Schools are required to provide transportation to the school of origin if requested, to minimize disruption in the student's education
  - The District must provide transportation immediately upon request



### Residency Assistance

#### **Key Responsibilities:**

- •Collaboration with Residency Office: Partner with the residency office to ensure that only students within the school district's boundaries utilize bus services.
- •Investigation of Bus Stops: Monitor and investigate bus stops to identify if children from outside the District are being dropped off.

#### Impact of Effective Residency Verification:

- •Fair Access: Ensures that transportation resources are fairly distributed among eligible students.
- •Cost Efficiency: Helps manage transportation costs by preventing unauthorized use of services.
- •Enhanced Safety: Promotes the safety and security of all students by accurately tracking bus stop usage.

# Coming Up...

In April 2022, the New York State Legislature passed a budget to transition school bus fleets to zero-emissions. *The legislation requires by:* 







With roughly 50,000 school buses across New York State, the legislation poses challenges for school districts to consider when planning for such a transition, including fleet distances, charging times, and reliability. School districts will need to implement electric charging stations, identify potential solar applications, and implement significant utility infrastructure upgrades to transition a large electric bus fleet.
